



BEARFACTS 1995 – 2005

Camas , Idaho [16025]

Camas is one of 44 counties in Idaho. It is not part of a Metropolitan Area. Its 2005 population of 1,062 ranked 43rd in the state.

PER CAPITA PERSONAL INCOME

In 2005 Camas had a per capita personal income (PCPI) of \$26,360. This PCPI ranked 10th in the state and was 93 percent of the state average, \$28,301, and 76 percent of the national average, \$34,757. The 2005 PCPI reflected an increase of 4.8 percent from 2004. The 2004-2005 state change was 3.4 percent and the national change was 4.9 percent. In 1995 the PCPI of Camas was \$17,244 and ranked 19th in the state. The 1995-2005 average annual growth rate of PCPI was 4.3 percent. The average annual growth rate for the state was 3.8 percent and for the nation was 4.2 percent.

TOTAL PERSONAL INCOME

In 2005 Camas had a total personal income (TPI) of \$27,994*. This TPI ranked 43rd in the state and accounted for 0.1 percent of the state total. In 1995 the TPI of Camas was \$15,399* and ranked 44th in the state. The 2005 TPI reflected an increase of 9.1 percent from 2004. The 2004-2005 state change was 6.0 percent and the national change was 5.9 percent. The 1995-2005 average annual growth rate of TPI was 6.2 percent. The average annual growth rate for the state was 5.8 percent and for the nation was 5.3 percent.

COMPONENTS OF TOTAL PERSONAL INCOME

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of Camas. In 2005 net earnings accounted for 70.3 percent of TPI (compared with 60.6 in 1995); dividends, interest, and rent were 18.1 percent (compared with 26.4 in 1995); and personal current transfer receipts were 11.6 percent (compared with 13.0 in 1995). From 2004 to 2005 net earnings increased 13.0 percent; dividends, interest, and rent increased 2.3 percent; and personal current transfer receipts decreased 1.3 percent. From 1995 to 2005 net earnings increased on average 7.7 percent each year; dividends, interest, and rent increased on average 2.2 percent; and personal current transfer receipts increased on average 5.0 percent.

EARNINGS BY PLACE OF WORK

Earnings of persons employed in Camas increased from \$12,307* in 2004 to \$14,358* in 2005, an increase of 16.7 percent. The 2004-2005 state change was 7.0 percent and the national change was 5.4 percent. The average annual growth rate from the 1995 estimate of \$7,171* to the 2005 estimate was 7.2 percent. The average annual growth rate for the state was 5.6 percent and for the nation was 5.5 percent.
