



BEARFACTS 1995 – 2005

Issaquena , Mississippi [28055]

Issaquena is one of 82 counties in Mississippi. It is not part of a Metropolitan Area. Its 2005 population of 1,819 ranked 82nd in the state.

PER CAPITA PERSONAL INCOME

In 2005 Issaquena had a per capita personal income (PCPI) of \$19,669. This PCPI ranked 70th in the state and was 77 percent of the state average, \$25,490, and 57 percent of the national average, \$34,757. The 2005 PCPI reflected an increase of 6.1 percent from 2004. The 2004-2005 state change was 5.6 percent and the national change was 4.9 percent. In 1995 the PCPI of Issaquena was \$11,688 and ranked 81st in the state. The 1995-2005 average annual growth rate of PCPI was 5.3 percent. The average annual growth rate for the state was 4.2 percent and for the nation was 4.2 percent.

TOTAL PERSONAL INCOME

In 2005 Issaquena had a total personal income (TPI) of \$35,778*. This TPI ranked 82nd in the state and accounted for 0.0 percent of the state total. In 1995 the TPI of Issaquena was \$23,317* and ranked 82nd in the state. The 2005 TPI reflected an increase of 1.7 percent from 2004. The 2004-2005 state change was 6.1 percent and the national change was 5.9 percent. The 1995-2005 average annual growth rate of TPI was 4.4 percent. The average annual growth rate for the state was 4.9 percent and for the nation was 5.3 percent.

COMPONENTS OF TOTAL PERSONAL INCOME

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of Issaquena. In 2005 net earnings accounted for 70.4 percent of TPI (compared with 60.3 in 1995); dividends, interest, and rent were 7.8 percent (compared with 16.0 in 1995); and personal current transfer receipts were 21.8 percent (compared with 23.7 in 1995). From 2004 to 2005 net earnings decreased 0.3 percent; dividends, interest, and rent increased 2.4 percent; and personal current transfer receipts increased 8.1 percent. From 1995 to 2005 net earnings increased on average 6.0 percent each year; dividends, interest, and rent decreased on average 2.9 percent; and personal current transfer receipts increased on average 3.5 percent.

EARNINGS BY PLACE OF WORK

Earnings of persons employed in Issaquena decreased from \$18,754* in 2004 to \$18,463* in 2005, a decrease of 1.6 percent. The 2004-2005 state change was 3.7 percent and the national change was 5.4 percent. The average annual growth rate from the 1995 estimate of \$8,438* to the 2005 estimate was 8.1 percent. The average annual growth rate for the state was 4.5 percent and for the nation was 5.5 percent.
