



BEARFACTS 1995 – 2005

Minnehaha , South Dakota [46099]

Minnehaha is one of 66 counties in South Dakota. It is part of the [Sioux Falls, SD \(MSA\)](#). Its 2005 population of 166,871 ranked 1st in the state.

PER CAPITA PERSONAL INCOME

In 2005 Minnehaha had a per capita personal income (PCPI) of \$35,868. This PCPI ranked 7th in the state and was 114 percent of the state average, \$31,557, and 103 percent of the national average, \$34,757. The 2005 PCPI reflected an increase of 3.7 percent from 2004. The 2004-2005 state change was 2.4 percent and the national change was 4.9 percent. In 1995 the PCPI of Minnehaha was \$23,569 and ranked 4th in the state. The 1995-2005 average annual growth rate of PCPI was 4.3 percent. The average annual growth rate for the state was 4.9 percent and for the nation was 4.2 percent.

TOTAL PERSONAL INCOME

In 2005 Minnehaha had a total personal income (TPI) of \$5,985,285*. This TPI ranked 1st in the state and accounted for 24.3 percent of the state total. In 1995 the TPI of Minnehaha was \$3,251,359* and ranked 1st in the state. The 2005 TPI reflected an increase of 6.3 percent from 2004. The 2004-2005 state change was 3.2 percent and the national change was 5.9 percent. The 1995-2005 average annual growth rate of TPI was 6.3 percent. The average annual growth rate for the state was 5.5 percent and for the nation was 5.3 percent.

COMPONENTS OF TOTAL PERSONAL INCOME

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of Minnehaha. In 2005 net earnings accounted for 70.0 percent of TPI (compared with 70.2 in 1995); dividends, interest, and rent were 18.8 percent (compared with 19.5 in 1995); and personal current transfer receipts were 11.1 percent (compared with 10.3 in 1995). From 2004 to 2005 net earnings increased 4.6 percent; dividends, interest, and rent increased 10.2 percent; and personal current transfer receipts increased 11.2 percent. From 1995 to 2005 net earnings increased on average 6.3 percent each year; dividends, interest, and rent increased on average 5.9 percent; and personal current transfer receipts increased on average 7.1 percent.

EARNINGS BY PLACE OF WORK

Earnings of persons employed in Minnehaha increased from \$5,272,886* in 2004 to \$5,582,635* in 2005, an increase of 5.9 percent. The 2004-2005 state change was 3.2 percent and the national change was 5.4 percent. The average annual growth rate from the 1995 estimate of \$2,933,163* to the 2005 estimate was 6.6 percent. The average annual growth rate for the state was 5.6 percent and for the nation was 5.5 percent.
