



BEARFACTS 1996 – 2006

Hutchinson , South Dakota [46067]

Hutchinson is one of 66 counties in South Dakota. It is not part of a Metropolitan Area. Its 2006 population of 7,388 ranked 23rd in the state.

PER CAPITA PERSONAL INCOME

In 2006 Hutchinson had a per capita personal income (PCPI) of \$30,340. This PCPI ranked 25th in the state and was 95 percent of the state average, \$32,030, and 83 percent of the national average, \$36,714. The 2006 PCPI reflected an increase of 6.2 percent from 2005. The 2005-2006 state change was 1.5 percent and the national change was 5.6 percent. In 1996 the PCPI of Hutchinson was \$23,774 and ranked 10th in the state. The 1996-2006 average annual growth rate of PCPI was 2.5 percent. The average annual growth rate for the state was 4.1 percent and for the nation was 4.3 percent.

TOTAL PERSONAL INCOME

In 2006 Hutchinson had a total personal income (TPI) of \$224,151*. This TPI ranked 22nd in the state and accounted for 0.9 percent of the state total. In 1996 the TPI of Hutchinson was \$193,137* and ranked 19th in the state. The 2006 TPI reflected an increase of 4.6 percent from 2005. The 2005-2006 state change was 2.6 percent and the national change was 6.7 percent. The 1996-2006 average annual growth rate of TPI was 1.5 percent. The average annual growth rate for the state was 4.7 percent and for the nation was 5.4 percent.

COMPONENTS OF TOTAL PERSONAL INCOME

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of Hutchinson. In 2006 net earnings accounted for 49.8 percent of TPI (compared with 60.4 in 1996); dividends, interest, and rent were 30.2 percent (compared with 24.0 in 1996); and personal current transfer receipts were 19.9 percent (compared with 15.6 in 1996). From 2005 to 2006 net earnings increased 2.4 percent; dividends, interest, and rent increased 5.9 percent; and personal current transfer receipts increased 8.7 percent. From 1996 to 2006 net earnings decreased on average 0.4 percent each year; dividends, interest, and rent increased on average 3.9 percent; and personal current transfer receipts increased on average 4.0 percent.

EARNINGS BY PLACE OF WORK

Earnings of persons employed in Hutchinson increased from \$108,759* in 2005 to \$111,964* in 2006, an increase of 2.9 percent. The 2005-2006 state change was 1.1 percent and the national change was 5.7 percent. The average annual growth rate from the 1996 estimate of \$121,242* to the 2006 estimate was - 0.8 percent. The average annual growth rate for the state was 4.6 percent and for the nation was 5.5 percent.
