



BEARFACTS 1988 – 1998

La Plata , Colorado [08067]

La Plata is one of 63 counties in Colorado. It is part of the Durango, CO Micropolitan SA. Its 1998 population of 42,318 ranked 13th in the state.

PER CAPITA PERSONAL INCOME

In 1998 La Plata had a per capita personal income (PCPI) of \$24,584. This PCPI ranked 22nd in the state and was 85 percent of the state average, \$28,784, and 91 percent of the national average, \$26,883. The 1998 PCPI reflected an increase of 6.5 percent from 1997. The 1997-1998 state change was 7.2 percent and the national change was 6.1 percent. In 1988 the PCPI of La Plata was \$14,055 and ranked 37th in the state. The 1988-1998 average annual growth rate of PCPI was 5.8 percent. The average annual growth rate for the state was 5.3 percent and for the nation was 4.5 percent.

TOTAL PERSONAL INCOME

In 1998 La Plata had a total personal income (TPI) of \$1,040,328*. This TPI ranked 13th in the state and accounted for 0.9 percent of the state total. In 1988 the TPI of La Plata was \$440,101* and ranked 12th in the state. The 1998 TPI reflected an increase of 8.1 percent from 1997. The 1997-1998 state change was 9.8 percent and the national change was 7.4 percent. The 1988-1998 average annual growth rate of TPI was 9.0 percent. The average annual growth rate for the state was 7.8 percent and for the nation was 5.8 percent.

COMPONENTS OF TOTAL PERSONAL INCOME

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of La Plata. In 1998 net earnings accounted for 62.0 percent of TPI (compared with 63.3 in 1988); dividends, interest, and rent were 28.7 percent (compared with 25.9 in 1988); and personal current transfer receipts were 9.2 percent (compared with 10.8 in 1988). From 1997 to 1998 net earnings increased 6.6 percent; dividends, interest, and rent increased 13.1 percent; and personal current transfer receipts increased 4.2 percent. From 1988 to 1998 net earnings increased on average 8.8 percent each year; dividends, interest, and rent increased on average 10.1 percent; and personal current transfer receipts increased on average 7.4 percent.

EARNINGS BY PLACE OF WORK

Earnings of persons employed in La Plata increased from \$669,283* in 1997 to \$709,059* in 1998, an increase of 5.9 percent. The 1997-1998 state change was 10.2 percent and the national change was 7.8 percent. The average annual growth rate from the 1988 estimate of \$293,893* to the 1998 estimate was 9.2 percent. The average annual growth rate for the state was 7.8 percent and for the nation was 5.5 percent.
