



BEARFACTS 1988 – 1998

Brantley , Georgia [13025]

Brantley is one of 159 counties in Georgia. It is part of the [Brunswick, GA \(MSA\)](#). Its 1998 population of 13,914 ranked 105th in the state.

PER CAPITA PERSONAL INCOME

In 1998 Brantley had a per capita personal income (PCPI) of \$16,020. This PCPI ranked 145th in the state and was 63 percent of the state average, \$25,279, and 60 percent of the national average, \$26,883. The 1998 PCPI reflected an increase of 3.9 percent from 1997. The 1997-1998 state change was 6.2 percent and the national change was 6.1 percent. In 1988 the PCPI of Brantley was \$9,884 and ranked 150th in the state. The 1988-1998 average annual growth rate of PCPI was 4.9 percent. The average annual growth rate for the state was 4.9 percent and for the nation was 4.5 percent.

TOTAL PERSONAL INCOME

In 1998 Brantley had a total personal income (TPI) of \$222,896*. This TPI ranked 111th in the state and accounted for 0.1 percent of the state total. In 1988 the TPI of Brantley was \$104,643* and ranked 119th in the state. The 1998 TPI reflected an increase of 6.3 percent from 1997. The 1997-1998 state change was 8.7 percent and the national change was 7.4 percent. The 1988-1998 average annual growth rate of TPI was 7.9 percent. The average annual growth rate for the state was 7.2 percent and for the nation was 5.8 percent.

COMPONENTS OF TOTAL PERSONAL INCOME

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of Brantley. In 1998 net earnings accounted for 65.9 percent of TPI (compared with 74.2 in 1988); dividends, interest, and rent were 12.6 percent (compared with 10.3 in 1988); and personal current transfer receipts were 21.6 percent (compared with 15.4 in 1988). From 1997 to 1998 net earnings increased 5.6 percent; dividends, interest, and rent increased 12.7 percent; and personal current transfer receipts increased 5.0 percent. From 1988 to 1998 net earnings increased on average 6.6 percent each year; dividends, interest, and rent increased on average 10.0 percent; and personal current transfer receipts increased on average 11.5 percent.

EARNINGS BY PLACE OF WORK

Earnings of persons employed in Brantley increased from \$63,473* in 1997 to \$67,877* in 1998, an increase of 6.9 percent. The 1997-1998 state change was 9.2 percent and the national change was 7.8 percent. The average annual growth rate from the 1988 estimate of \$34,306* to the 1998 estimate was 7.1 percent. The average annual growth rate for the state was 6.9 percent and for the nation was 5.5 percent.
