



BEARFACTS 1988 – 1998

St. Francois , Missouri [29187]

St. Francois is one of 115 counties in Missouri. It is part of the Farmington, MO Micropolitan SA. Its 1998 population of 54,901 ranked 16th in the state.

PER CAPITA PERSONAL INCOME

In 1998 St. Francois had a per capita personal income (PCPI) of \$18,341. This PCPI ranked 66th in the state and was 74 percent of the state average, \$24,923, and 68 percent of the national average, \$26,883. The 1998 PCPI reflected an increase of 6.6 percent from 1997. The 1997-1998 state change was 5.1 percent and the national change was 6.1 percent. In 1988 the PCPI of St. Francois was \$11,270 and ranked 78th in the state. The 1988-1998 average annual growth rate of PCPI was 5.0 percent. The average annual growth rate for the state was 4.5 percent and for the nation was 4.5 percent.

TOTAL PERSONAL INCOME

In 1998 St. Francois had a total personal income (TPI) of \$1,006,924*. This TPI ranked 18th in the state and accounted for 0.7 percent of the state total. In 1988 the TPI of St. Francois was \$537,726* and ranked 17th in the state. The 1998 TPI reflected an increase of 7.9 percent from 1997. The 1997-1998 state change was 5.9 percent and the national change was 7.4 percent. The 1988-1998 average annual growth rate of TPI was 6.5 percent. The average annual growth rate for the state was 5.4 percent and for the nation was 5.8 percent.

COMPONENTS OF TOTAL PERSONAL INCOME

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of St. Francois. In 1998 net earnings accounted for 60.4 percent of TPI (compared with 60.2 in 1988); dividends, interest, and rent were 15.4 percent (compared with 18.7 in 1988); and personal current transfer receipts were 24.2 percent (compared with 21.1 in 1988). From 1997 to 1998 net earnings increased 11.2 percent; dividends, interest, and rent increased 5.5 percent; and personal current transfer receipts increased 2.0 percent. From 1988 to 1998 net earnings increased on average 6.5 percent each year; dividends, interest, and rent increased on average 4.4 percent; and personal current transfer receipts increased on average 7.9 percent.

EARNINGS BY PLACE OF WORK

Earnings of persons employed in St. Francois increased from \$526,943* in 1997 to \$588,996* in 1998, an increase of 11.8 percent. The 1997-1998 state change was 6.2 percent and the national change was 7.8 percent. The average annual growth rate from the 1988 estimate of \$304,907* to the 1998 estimate was 6.8 percent. The average annual growth rate for the state was 5.2 percent and for the nation was 5.5 percent.
