



BEARFACTS 1988 – 1998

Vernon , Missouri [29217]

Vernon is one of 115 counties in Missouri. It is not part of a Metropolitan Area. Its 1998 population of 20,322 ranked 55th in the state.

PER CAPITA PERSONAL INCOME

In 1998 Vernon had a per capita personal income (PCPI) of \$18,910. This PCPI ranked 59th in the state and was 76 percent of the state average, \$24,923, and 70 percent of the national average, \$26,883. The 1998 PCPI reflected a decrease of 1.5 percent from 1997. The 1997-1998 state change was 5.1 percent and the national change was 6.1 percent. In 1988 the PCPI of Vernon was \$12,678 and ranked 42nd in the state. The 1988-1998 average annual growth rate of PCPI was 4.1 percent. The average annual growth rate for the state was 4.5 percent and for the nation was 4.5 percent.

TOTAL PERSONAL INCOME

In 1998 Vernon had a total personal income (TPI) of \$384,299*. This TPI ranked 51st in the state and accounted for 0.3 percent of the state total. In 1988 the TPI of Vernon was \$243,981* and ranked 48th in the state. The 1998 TPI reflected a decrease of 0.1 percent from 1997. The 1997-1998 state change was 5.9 percent and the national change was 7.4 percent. The 1988-1998 average annual growth rate of TPI was 4.6 percent. The average annual growth rate for the state was 5.4 percent and for the nation was 5.8 percent.

COMPONENTS OF TOTAL PERSONAL INCOME

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of Vernon. In 1998 net earnings accounted for 54.9 percent of TPI (compared with 55.7 in 1988); dividends, interest, and rent were 18.8 percent (compared with 20.1 in 1988); and personal current transfer receipts were 26.2 percent (compared with 24.1 in 1988). From 1997 to 1998 net earnings decreased 0.9 percent; dividends, interest, and rent increased 5.9 percent; and personal current transfer receipts decreased 2.4 percent. From 1988 to 1998 net earnings increased on average 4.5 percent each year; dividends, interest, and rent increased on average 3.9 percent; and personal current transfer receipts increased on average 5.5 percent.

EARNINGS BY PLACE OF WORK

Earnings of persons employed in Vernon decreased from \$233,121* in 1997 to \$228,276* in 1998, a decrease of 2.1 percent. The 1997-1998 state change was 6.2 percent and the national change was 7.8 percent. The average annual growth rate from the 1988 estimate of \$160,198* to the 1998 estimate was 3.6 percent. The average annual growth rate for the state was 5.2 percent and for the nation was 5.5 percent.
