



BEARFACTS 1988 – 1998

Hoke , North Carolina [37093]

Hoke is one of 100 counties in North Carolina. It is part of the [Fayetteville, NC \(MSA\)](#). Its 1998 population of 31,580 ranked 67th in the state.

PER CAPITA PERSONAL INCOME

In 1998 Hoke had a per capita personal income (PCPI) of \$15,760. This PCPI ranked 100th in the state and was 64 percent of the state average, \$24,743, and 59 percent of the national average, \$26,883. The 1998 PCPI reflected an increase of 1.4 percent from 1997. The 1997-1998 state change was 5.2 percent and the national change was 6.1 percent. In 1988 the PCPI of Hoke was \$9,408 and ranked 99th in the state. The 1988-1998 average annual growth rate of PCPI was 5.3 percent. The average annual growth rate for the state was 4.9 percent and for the nation was 4.5 percent.

TOTAL PERSONAL INCOME

In 1998 Hoke had a total personal income (TPI) of \$497,715*. This TPI ranked 73rd in the state and accounted for 0.3 percent of the state total. In 1988 the TPI of Hoke was \$211,850* and ranked 79th in the state. The 1998 TPI reflected an increase of 5.6 percent from 1997. The 1997-1998 state change was 7.2 percent and the national change was 7.4 percent. The 1988-1998 average annual growth rate of TPI was 8.9 percent. The average annual growth rate for the state was 6.8 percent and for the nation was 5.8 percent.

COMPONENTS OF TOTAL PERSONAL INCOME

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of Hoke. In 1998 net earnings accounted for 68.9 percent of TPI (compared with 72.2 in 1988); dividends, interest, and rent were 12.2 percent (compared with 13.2 in 1988); and personal current transfer receipts were 18.8 percent (compared with 14.6 in 1988). From 1997 to 1998 net earnings increased 4.8 percent; dividends, interest, and rent increased 13.4 percent; and personal current transfer receipts increased 4.0 percent. From 1988 to 1998 net earnings increased on average 8.4 percent each year; dividends, interest, and rent increased on average 8.1 percent; and personal current transfer receipts increased on average 11.7 percent.

EARNINGS BY PLACE OF WORK

Earnings of persons employed in Hoke decreased from \$233,897* in 1997 to \$232,760* in 1998, a decrease of 0.5 percent. The 1997-1998 state change was 7.2 percent and the national change was 7.8 percent. The average annual growth rate from the 1988 estimate of \$141,259* to the 1998 estimate was 5.1 percent. The average annual growth rate for the state was 6.3 percent and for the nation was 5.5 percent.
