



BEARFACTS 1988 – 1998

Pender , North Carolina [37141]

Pender is one of 100 counties in North Carolina. It is part of the [Wilmington, NC \(MSA\)](#). Its 1998 population of 39,585 ranked 58th in the state.

PER CAPITA PERSONAL INCOME

In 1998 Pender had a per capita personal income (PCPI) of \$19,139. This PCPI ranked 76th in the state and was 77 percent of the state average, \$24,743, and 71 percent of the national average, \$26,883. The 1998 PCPI reflected a decrease of 1.3 percent from 1997. The 1997-1998 state change was 5.2 percent and the national change was 6.1 percent. In 1988 the PCPI of Pender was \$12,420 and ranked 61st in the state. The 1988-1998 average annual growth rate of PCPI was 4.4 percent. The average annual growth rate for the state was 4.9 percent and for the nation was 4.5 percent.

TOTAL PERSONAL INCOME

In 1998 Pender had a total personal income (TPI) of \$757,601*. This TPI ranked 60th in the state and accounted for 0.4 percent of the state total. In 1988 the TPI of Pender was \$335,471* and ranked 65th in the state. The 1998 TPI reflected an increase of 2.7 percent from 1997. The 1997-1998 state change was 7.2 percent and the national change was 7.4 percent. The 1988-1998 average annual growth rate of TPI was 8.5 percent. The average annual growth rate for the state was 6.8 percent and for the nation was 5.8 percent.

COMPONENTS OF TOTAL PERSONAL INCOME

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of Pender. In 1998 net earnings accounted for 62.5 percent of TPI (compared with 66.3 in 1988); dividends, interest, and rent were 18.0 percent (compared with 17.7 in 1988); and personal current transfer receipts were 19.5 percent (compared with 16.1 in 1988). From 1997 to 1998 net earnings increased 1.4 percent; dividends, interest, and rent increased 4.6 percent; and personal current transfer receipts increased 5.1 percent. From 1988 to 1998 net earnings increased on average 7.9 percent each year; dividends, interest, and rent increased on average 8.7 percent; and personal current transfer receipts increased on average 10.6 percent.

EARNINGS BY PLACE OF WORK

Earnings of persons employed in Pender decreased from \$273,893* in 1997 to \$270,830* in 1998, a decrease of 1.1 percent. The 1997-1998 state change was 7.2 percent and the national change was 7.8 percent. The average annual growth rate from the 1988 estimate of \$134,336* to the 1998 estimate was 7.3 percent. The average annual growth rate for the state was 6.3 percent and for the nation was 5.5 percent.
