



BEARFACTS 1988 – 1998

Tooele , Utah [49045]

Tooele is one of 29 counties in Utah. It is part of the [Salt Lake City, UT \(MSA\)](#). Its 1998 population of 35,351 ranked 8th in the state.

PER CAPITA PERSONAL INCOME

In 1998 Tooele had a per capita personal income (PCPI) of \$19,063. This PCPI ranked 11th in the state and was 88 percent of the state average, \$21,708, and 71 percent of the national average, \$26,883. The 1998 PCPI reflected an increase of 4.4 percent from 1997. The 1997-1998 state change was 5.4 percent and the national change was 6.1 percent. In 1988 the PCPI of Tooele was \$12,549 and ranked 8th in the state. The 1988-1998 average annual growth rate of PCPI was 4.3 percent. The average annual growth rate for the state was 5.1 percent and for the nation was 4.5 percent.

TOTAL PERSONAL INCOME

In 1998 Tooele had a total personal income (TPI) of \$673,892*. This TPI ranked 9th in the state and accounted for 1.4 percent of the state total. In 1988 the TPI of Tooele was \$339,167* and ranked 8th in the state. The 1998 TPI reflected an increase of 11.7 percent from 1997. The 1997-1998 state change was 7.7 percent and the national change was 7.4 percent. The 1988-1998 average annual growth rate of TPI was 7.1 percent. The average annual growth rate for the state was 7.8 percent and for the nation was 5.8 percent.

COMPONENTS OF TOTAL PERSONAL INCOME

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of Tooele. In 1998 net earnings accounted for 76.1 percent of TPI (compared with 74.4 in 1988); dividends, interest, and rent were 14.3 percent (compared with 16.7 in 1988); and personal current transfer receipts were 9.5 percent (compared with 8.9 in 1988). From 1997 to 1998 net earnings increased 12.2 percent; dividends, interest, and rent increased 14.1 percent; and personal current transfer receipts increased 4.5 percent. From 1988 to 1998 net earnings increased on average 7.4 percent each year; dividends, interest, and rent increased on average 5.5 percent; and personal current transfer receipts increased on average 7.8 percent.

EARNINGS BY PLACE OF WORK

Earnings of persons employed in Tooele increased from \$432,517* in 1997 to \$449,402* in 1998, an increase of 3.9 percent. The 1997-1998 state change was 7.9 percent and the national change was 7.8 percent. The average annual growth rate from the 1988 estimate of \$347,118* to the 1998 estimate was 2.6 percent. The average annual growth rate for the state was 8.1 percent and for the nation was 5.5 percent.
