



BEARFACTS 1989 – 1999

New Haven , Connecticut [09009]

New Haven is one of 8 counties in Connecticut. It is part of the [New Haven-Milford, CT \(MSA\)](#). Its 1999 population of 820,396 ranked 3rd in the state.

PER CAPITA PERSONAL INCOME

In 1999 New Haven had a per capita personal income (PCPI) of \$32,039. This PCPI ranked 5th in the state and was 84 percent of the state average, \$38,332, and 115 percent of the national average, \$27,939. The 1999 PCPI reflected an increase of 4.1 percent from 1998. The 1998-1999 state change was 4.1 percent and the national change was 3.9 percent. In 1989 the PCPI of New Haven was \$22,690 and ranked 5th in the state. The 1989-1999 average annual growth rate of PCPI was 3.5 percent. The average annual growth rate for the state was 4.1 percent and for the nation was 4.2 percent.

TOTAL PERSONAL INCOME

In 1999 New Haven had a total personal income (TPI) of \$26,285,030*. This TPI ranked 3rd in the state and accounted for 20.2 percent of the state total. In 1989 the TPI of New Haven was \$18,242,946* and ranked 3rd in the state. The 1999 TPI reflected an increase of 4.5 percent from 1998. The 1998-1999 state change was 4.8 percent and the national change was 5.1 percent. The 1989-1999 average annual growth rate of TPI was 3.7 percent. The average annual growth rate for the state was 4.4 percent and for the nation was 5.5 percent.

COMPONENTS OF TOTAL PERSONAL INCOME

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of New Haven. In 1999 net earnings accounted for 69.9 percent of TPI (compared with 69.0 in 1989); dividends, interest, and rent were 15.8 percent (compared with 19.8 in 1989); and personal current transfer receipts were 14.3 percent (compared with 11.1 in 1989). From 1998 to 1999 net earnings increased 6.0 percent; dividends, interest, and rent increased 0.2 percent; and personal current transfer receipts increased 2.3 percent. From 1989 to 1999 net earnings increased on average 3.8 percent each year; dividends, interest, and rent increased on average 1.4 percent; and personal current transfer receipts increased on average 6.4 percent.

EARNINGS BY PLACE OF WORK

Earnings of persons employed in New Haven increased from \$17,713,183* in 1998 to \$18,561,433* in 1999, an increase of 4.8 percent. The 1998-1999 state change was 6.5 percent and the national change was 6.8 percent. The average annual growth rate from the 1989 estimate of \$12,598,941* to the 1999 estimate was 4.0 percent. The average annual growth rate for the state was 4.5 percent and for the nation was 5.6 percent.
