



BEARFACTS 1989 – 1999

Linn , Iowa [19113]

Linn is one of 99 counties in Iowa. It is part of the [Cedar Rapids, IA \(MSA\)](#). Its 1999 population of 189,931 ranked 2nd in the state.

PER CAPITA PERSONAL INCOME

In 1999 Linn had a per capita personal income (PCPI) of \$29,939. This PCPI ranked 2nd in the state and was 119 percent of the state average, \$25,118, and 107 percent of the national average, \$27,939. The 1999 PCPI reflected an increase of 4.0 percent from 1998. The 1998-1999 state change was 1.7 percent and the national change was 3.9 percent. In 1989 the PCPI of Linn was \$19,233 and ranked 2nd in the state. The 1989-1999 average annual growth rate of PCPI was 4.5 percent. The average annual growth rate for the state was 4.2 percent and for the nation was 4.2 percent.

TOTAL PERSONAL INCOME

In 1999 Linn had a total personal income (TPI) of \$5,686,311*. This TPI ranked 2nd in the state and accounted for 7.8 percent of the state total. In 1989 the TPI of Linn was \$3,225,371* and ranked 2nd in the state. The 1999 TPI reflected an increase of 5.6 percent from 1998. The 1998-1999 state change was 2.2 percent and the national change was 5.1 percent. The 1989-1999 average annual growth rate of TPI was 5.8 percent. The average annual growth rate for the state was 4.8 percent and for the nation was 5.5 percent.

COMPONENTS OF TOTAL PERSONAL INCOME

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of Linn. In 1999 net earnings accounted for 72.2 percent of TPI (compared with 69.7 in 1989); dividends, interest, and rent were 17.5 percent (compared with 20.3 in 1989); and personal current transfer receipts were 10.3 percent (compared with 10.0 in 1989). From 1998 to 1999 net earnings increased 7.7 percent; dividends, interest, and rent decreased 2.3 percent; and personal current transfer receipts increased 4.8 percent. From 1989 to 1999 net earnings increased on average 6.2 percent each year; dividends, interest, and rent increased on average 4.3 percent; and personal current transfer receipts increased on average 6.1 percent.

EARNINGS BY PLACE OF WORK

Earnings of persons employed in Linn increased from \$4,783,176* in 1998 to \$5,150,252* in 1999, an increase of 7.7 percent. The 1998-1999 state change was 3.7 percent and the national change was 6.8 percent. The average annual growth rate from the 1989 estimate of \$2,739,611* to the 1999 estimate was 6.5 percent. The average annual growth rate for the state was 5.0 percent and for the nation was 5.6 percent.
