



BEARFACTS 1989 – 1999

Knox , Missouri [29103]

Knox is one of 115 counties in Missouri. It is not part of a Metropolitan Area. Its 1999 population of 4,378 ranked 112th in the state.

PER CAPITA PERSONAL INCOME

In 1999 Knox had a per capita personal income (PCPI) of \$16,723. This PCPI ranked 94th in the state and was 65 percent of the state average, \$25,697, and 60 percent of the national average, \$27,939. The 1999 PCPI reflected a decrease of 6.9 percent from 1998. The 1998-1999 state change was 3.1 percent and the national change was 3.9 percent. In 1989 the PCPI of Knox was \$13,302 and ranked 54th in the state. The 1989-1999 average annual growth rate of PCPI was 2.3 percent. The average annual growth rate for the state was 4.2 percent and for the nation was 4.2 percent.

TOTAL PERSONAL INCOME

In 1999 Knox had a total personal income (TPI) of \$73,215*. This TPI ranked 113th in the state and accounted for 0.1 percent of the state total. In 1989 the TPI of Knox was \$60,497* and ranked 110th in the state. The 1999 TPI reflected a decrease of 7.8 percent from 1998. The 1998-1999 state change was 3.9 percent and the national change was 5.1 percent. The 1989-1999 average annual growth rate of TPI was 1.9 percent. The average annual growth rate for the state was 5.1 percent and for the nation was 5.5 percent.

COMPONENTS OF TOTAL PERSONAL INCOME

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of Knox. In 1999 net earnings accounted for 43.5 percent of TPI (compared with 53.6 in 1989); dividends, interest, and rent were 30.0 percent (compared with 26.6 in 1989); and personal current transfer receipts were 26.5 percent (compared with 19.8 in 1989). From 1998 to 1999 net earnings decreased 14.8 percent; dividends, interest, and rent decreased 3.6 percent; and personal current transfer receipts increased 1.0 percent. From 1989 to 1999 net earnings decreased on average 0.2 percent each year; dividends, interest, and rent increased on average 3.2 percent; and personal current transfer receipts increased on average 4.9 percent.

EARNINGS BY PLACE OF WORK

Earnings of persons employed in Knox decreased from \$33,613* in 1998 to \$27,971* in 1999, a decrease of 16.8 percent. The 1998-1999 state change was 5.3 percent and the national change was 6.8 percent. The average annual growth rate from the 1989 estimate of \$31,865* to the 1999 estimate was - 1.3 percent. The average annual growth rate for the state was 5.2 percent and for the nation was 5.6 percent.
