



BEARFACTS 1989 – 1999

Lewis , Missouri [29111]

Lewis is one of 115 counties in Missouri. It is part of the Quincy, IL-MO Micropolitan SA. Its 1999 population of 10,402 ranked 86th in the state.

PER CAPITA PERSONAL INCOME

In 1999 Lewis had a per capita personal income (PCPI) of \$16,367. This PCPI ranked 101st in the state and was 64 percent of the state average, \$25,697, and 59 percent of the national average, \$27,939. The 1999 PCPI reflected a decrease of 1.4 percent from 1998. The 1998-1999 state change was 3.1 percent and the national change was 3.9 percent. In 1989 the PCPI of Lewis was \$12,008 and ranked 79th in the state. The 1989-1999 average annual growth rate of PCPI was 3.1 percent. The average annual growth rate for the state was 4.2 percent and for the nation was 4.2 percent.

TOTAL PERSONAL INCOME

In 1999 Lewis had a total personal income (TPI) of \$170,250*. This TPI ranked 91st in the state and accounted for 0.1 percent of the state total. In 1989 the TPI of Lewis was \$123,362* and ranked 84th in the state. The 1999 TPI reflected a decrease of 0.7 percent from 1998. The 1998-1999 state change was 3.9 percent and the national change was 5.1 percent. The 1989-1999 average annual growth rate of TPI was 3.3 percent. The average annual growth rate for the state was 5.1 percent and for the nation was 5.5 percent.

COMPONENTS OF TOTAL PERSONAL INCOME

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of Lewis. In 1999 net earnings accounted for 57.4 percent of TPI (compared with 57.8 in 1989); dividends, interest, and rent were 19.8 percent (compared with 24.2 in 1989); and personal current transfer receipts were 22.8 percent (compared with 17.9 in 1989). From 1998 to 1999 net earnings decreased 2.3 percent; dividends, interest, and rent decreased 1.5 percent; and personal current transfer receipts increased 4.4 percent. From 1989 to 1999 net earnings increased on average 3.2 percent each year; dividends, interest, and rent increased on average 1.2 percent; and personal current transfer receipts increased on average 5.8 percent.

EARNINGS BY PLACE OF WORK

Earnings of persons employed in Lewis decreased from \$75,597* in 1998 to \$72,305* in 1999, a decrease of 4.4 percent. The 1998-1999 state change was 5.3 percent and the national change was 6.8 percent. The average annual growth rate from the 1989 estimate of \$55,081* to the 1999 estimate was 2.8 percent. The average annual growth rate for the state was 5.2 percent and for the nation was 5.6 percent.
