



BEARFACTS 1990 – 2000

Aleutians East Borough , Alaska [02013]

Aleutians East Borough is one of 27 counties in Alaska. It is not part of a Metropolitan Area. Its 2000 population of 2,686 ranked 22nd in the state.

PER CAPITA PERSONAL INCOME

In 2000 Aleutians East Borough had a per capita personal income (PCPI) of \$22,677. This PCPI ranked 19th in the state and was 76 percent of the state average, \$29,870, and 76 percent of the national average, \$29,847. The 2000 PCPI reflected an increase of 2.2 percent from 1999. The 1999-2000 state change was 6.3 percent and the national change was 6.8 percent. In 1990 the PCPI of Aleutians East Borough was \$18,524 and ranked 16th in the state. The 1990-2000 average annual growth rate of PCPI was 2.0 percent. The average annual growth rate for the state was 2.7 percent and for the nation was 4.4 percent.

TOTAL PERSONAL INCOME

In 2000 Aleutians East Borough had a total personal income (TPI) of \$60,911*. This TPI ranked 24th in the state and accounted for 0.3 percent of the state total. In 1990 the TPI of Aleutians East Borough was \$45,884* and ranked 24th in the state. The 2000 TPI reflected an increase of 0.2 percent from 1999. The 1999-2000 state change was 6.7 percent and the national change was 8.0 percent. The 1990-2000 average annual growth rate of TPI was 2.9 percent. The average annual growth rate for the state was 4.0 percent and for the nation was 5.6 percent.

COMPONENTS OF TOTAL PERSONAL INCOME

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of Aleutians East Borough. In 2000 net earnings accounted for 72.5 percent of TPI (compared with 79.3 in 1990); dividends, interest, and rent were 8.8 percent (compared with 12.4 in 1990); and personal current transfer receipts were 18.8 percent (compared with 8.4 in 1990). From 1999 to 2000 net earnings decreased 2.3 percent; dividends, interest, and rent increased 5.0 percent; and personal current transfer receipts increased 8.9 percent. From 1990 to 2000 net earnings increased on average 2.0 percent each year; dividends, interest, and rent decreased on average 0.6 percent; and personal current transfer receipts increased on average 11.5 percent.

EARNINGS BY PLACE OF WORK

Earnings of persons employed in Aleutians East Borough decreased from \$62,529* in 1999 to \$59,819* in 2000, a decrease of 4.3 percent. The 1999-2000 state change was 5.1 percent and the national change was 8.0 percent. The average annual growth rate from the 1990 estimate of \$46,932* to the 2000 estimate was 2.5 percent. The average annual growth rate for the state was 3.0 percent and for the nation was 5.8 percent.
