



BEARFACTS 1990 – 2000

El Paso , Colorado [08041]

El Paso is one of 63 counties in Colorado. It is part of the [Colorado Springs, CO \(MSA\)](#). Its 2000 population of 519,436 ranked 3rd in the state.

PER CAPITA PERSONAL INCOME

In 2000 El Paso had a per capita personal income (PCPI) of \$29,596. This PCPI ranked 17th in the state and was 89 percent of the state average, \$33,364, and 99 percent of the national average, \$29,847. The 2000 PCPI reflected an increase of 8.1 percent from 1999. The 1999-2000 state change was 9.4 percent and the national change was 6.8 percent. In 1990 the PCPI of El Paso was \$17,674 and ranked 20th in the state. The 1990-2000 average annual growth rate of PCPI was 5.3 percent. The average annual growth rate for the state was 5.5 percent and for the nation was 4.4 percent.

TOTAL PERSONAL INCOME

In 2000 El Paso had a total personal income (TPI) of \$15,373,444*. This TPI ranked 4th in the state and accounted for 10.6 percent of the state total. In 1990 the TPI of El Paso was \$7,025,182* and ranked 4th in the state. The 2000 TPI reflected an increase of 10.3 percent from 1999. The 1999-2000 state change was 12.1 percent and the national change was 8.0 percent. The 1990-2000 average annual growth rate of TPI was 8.1 percent. The average annual growth rate for the state was 8.4 percent and for the nation was 5.6 percent.

COMPONENTS OF TOTAL PERSONAL INCOME

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of El Paso. In 2000 net earnings accounted for 73.0 percent of TPI (compared with 70.9 in 1990); dividends, interest, and rent were 17.8 percent (compared with 19.5 in 1990); and personal current transfer receipts were 9.2 percent (compared with 9.6 in 1990). From 1999 to 2000 net earnings increased 11.0 percent; dividends, interest, and rent increased 9.4 percent; and personal current transfer receipts increased 6.8 percent. From 1990 to 2000 net earnings increased on average 8.5 percent each year; dividends, interest, and rent increased on average 7.2 percent; and personal current transfer receipts increased on average 7.7 percent.

EARNINGS BY PLACE OF WORK

Earnings of persons employed in El Paso increased from \$11,306,709* in 1999 to \$12,519,411* in 2000, an increase of 10.7 percent. The 1999-2000 state change was 12.7 percent and the national change was 8.0 percent. The average annual growth rate from the 1990 estimate of \$5,552,848* to the 2000 estimate was 8.5 percent. The average annual growth rate for the state was 8.8 percent and for the nation was 5.8 percent.
