



BEARFACTS 1990 – 2000

Boise City-Nampa (MSA) [14260]

Boise City-Nampa is one of 363 Metropolitan Statistical Areas (MSAs) in the nation. Its 2000 population of 468,830 ranked 97th in the nation.

PER CAPITA PERSONAL INCOME

In 2000 Boise City-Nampa had a per capita personal income (PCPI) of \$28,616. This PCPI ranked 110th in the United States and was 96 percent of the national average, \$29,847. The 2000 PCPI reflected an increase of 7.8 percent from 1999. The 1999-2000 national change was 6.8 percent. In 1990 the PCPI of Boise City-Nampa was \$17,476 and ranked 154th in the United States. The 1990-2000 average annual growth rate of PCPI was 5.1 percent. The average annual growth rate for the nation was 4.4 percent.

TOTAL PERSONAL INCOME

In 2000 Boise City-Nampa had a total personal income (TPI) of \$13,415,845*. This TPI ranked 93rd in the United States. In 1990 the TPI of Boise City-Nampa was \$5,632,938* and ranked 124th in the United States. The 2000 TPI reflected an increase of 11.6 percent from 1999. The 1999-2000 national change was 8.0 percent. The 1990-2000 average annual growth rate of TPI was 9.1 percent. The average annual growth rate for the nation was 5.6 percent.

COMPONENTS OF TOTAL PERSONAL INCOME

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of Boise City-Nampa. In 2000 net earnings accounted for 72.2 percent of TPI (compared with 69.9 in 1990); dividends, interest, and rent were 17.8 percent (compared with 19.3 in 1990); and personal current transfer receipts were 10.0 percent (compared with 10.7 in 1990). From 1999 to 2000 net earnings increased 13.4 percent; dividends, interest, and rent increased 6.5 percent; and personal current transfer receipts increased 8.4 percent. From 1990 to 2000 net earnings increased on average 9.4 percent each year; dividends, interest, and rent increased on average 8.2 percent; and personal current transfer receipts increased on average 8.3 percent.

EARNINGS BY PLACE OF WORK

Earnings of persons employed in Boise City-Nampa increased from \$9,633,330* in 1999 to \$10,919,103* in 2000, an increase of 13.3 percent. The 1999-2000 national change was 8.0 percent. The average annual growth rate from the 1990 estimate of \$4,440,955* to the 2000 estimate was 9.4 percent. The average annual growth rate for the nation was 5.8 percent.
