



BEARFACTS 1990 – 2000

Edgar , Illinois [17045]

Edgar is one of 102 counties in Illinois. It is not part of a Metropolitan Area. Its 2000 population of 19,657 ranked 61st in the state.

PER CAPITA PERSONAL INCOME

In 2000 Edgar had a per capita personal income (PCPI) of \$23,415. This PCPI ranked 54th in the state and was 73 percent of the state average, \$32,190, and 78 percent of the national average, \$29,847. The 2000 PCPI reflected an increase of 13.2 percent from 1999. The 1999-2000 state change was 6.5 percent and the national change was 6.8 percent. In 1990 the PCPI of Edgar was \$15,140 and ranked 61st in the state. The 1990-2000 average annual growth rate of PCPI was 4.5 percent. The average annual growth rate for the state was 4.5 percent and for the nation was 4.4 percent.

TOTAL PERSONAL INCOME

In 2000 Edgar had a total personal income (TPI) of \$460,260*. This TPI ranked 59th in the state and accounted for 0.1 percent of the state total. In 1990 the TPI of Edgar was \$296,044* and ranked 60th in the state. The 2000 TPI reflected an increase of 12.3 percent from 1999. The 1999-2000 state change was 7.2 percent and the national change was 8.0 percent. The 1990-2000 average annual growth rate of TPI was 4.5 percent. The average annual growth rate for the state was 5.3 percent and for the nation was 5.6 percent.

COMPONENTS OF TOTAL PERSONAL INCOME

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of Edgar. In 2000 net earnings accounted for 62.2 percent of TPI (compared with 59.0 in 1990); dividends, interest, and rent were 20.0 percent (compared with 23.3 in 1990); and personal current transfer receipts were 17.8 percent (compared with 17.7 in 1990). From 1999 to 2000 net earnings increased 16.8 percent; dividends, interest, and rent increased 6.3 percent; and personal current transfer receipts increased 4.5 percent. From 1990 to 2000 net earnings increased on average 5.1 percent each year; dividends, interest, and rent increased on average 2.9 percent; and personal current transfer receipts increased on average 4.6 percent.

EARNINGS BY PLACE OF WORK

Earnings of persons employed in Edgar increased from \$226,480* in 1999 to \$268,777* in 2000, an increase of 18.7 percent. The 1999-2000 state change was 6.5 percent and the national change was 8.0 percent. The average annual growth rate from the 1990 estimate of \$156,617* to the 2000 estimate was 5.5 percent. The average annual growth rate for the state was 5.4 percent and for the nation was 5.8 percent.
