



BEARFACTS 1990 – 2000

Chautauqua , Kansas [20019]

Chautauqua is one of 105 counties in Kansas. It is not part of a Metropolitan Area. Its 2000 population of 4,347 ranked 77th in the state.

PER CAPITA PERSONAL INCOME

In 2000 Chautauqua had a per capita personal income (PCPI) of \$21,146. This PCPI ranked 74th in the state and was 76 percent of the state average, \$27,693, and 71 percent of the national average, \$29,847. The 2000 PCPI reflected an increase of 12.6 percent from 1999. The 1999-2000 state change was 5.7 percent and the national change was 6.8 percent. In 1990 the PCPI of Chautauqua was \$12,797 and ranked 104th in the state. The 1990-2000 average annual growth rate of PCPI was 5.2 percent. The average annual growth rate for the state was 4.4 percent and for the nation was 4.4 percent.

TOTAL PERSONAL INCOME

In 2000 Chautauqua had a total personal income (TPI) of \$91,922*. This TPI ranked 76th in the state and accounted for 0.1 percent of the state total. In 1990 the TPI of Chautauqua was \$56,101* and ranked 93rd in the state. The 2000 TPI reflected an increase of 12.1 percent from 1999. The 1999-2000 state change was 6.3 percent and the national change was 8.0 percent. The 1990-2000 average annual growth rate of TPI was 5.1 percent. The average annual growth rate for the state was 5.2 percent and for the nation was 5.6 percent.

COMPONENTS OF TOTAL PERSONAL INCOME

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of Chautauqua. In 2000 net earnings accounted for 45.8 percent of TPI (compared with 46.7 in 1990); dividends, interest, and rent were 27.4 percent (compared with 27.2 in 1990); and personal current transfer receipts were 26.8 percent (compared with 26.1 in 1990). From 1999 to 2000 net earnings increased 17.3 percent; dividends, interest, and rent increased 8.5 percent; and personal current transfer receipts increased 7.5 percent. From 1990 to 2000 net earnings increased on average 4.9 percent each year; dividends, interest, and rent increased on average 5.1 percent; and personal current transfer receipts increased on average 5.3 percent.

EARNINGS BY PLACE OF WORK

Earnings of persons employed in Chautauqua increased from \$30,038* in 1999 to \$34,920* in 2000, an increase of 16.3 percent. The 1999-2000 state change was 5.1 percent and the national change was 8.0 percent. The average annual growth rate from the 1990 estimate of \$25,163* to the 2000 estimate was 3.3 percent. The average annual growth rate for the state was 5.4 percent and for the nation was 5.8 percent.
