



BEARFACTS 1990 – 2000

Bath , Kentucky [21011]

Bath is one of 120 counties in Kentucky. It is part of the Mount Sterling, KY Micropolitan SA. Its 2000 population of 11,128 ranked 95th in the state.

PER CAPITA PERSONAL INCOME

In 2000 Bath had a per capita personal income (PCPI) of \$19,056. This PCPI ranked 72nd in the state and was 78 percent of the state average, \$24,413, and 64 percent of the national average, \$29,847. The 2000 PCPI reflected an increase of 10.4 percent from 1999. The 1999-2000 state change was 7.2 percent and the national change was 6.8 percent. In 1990 the PCPI of Bath was \$11,491 and ranked 81st in the state. The 1990-2000 average annual growth rate of PCPI was 5.2 percent. The average annual growth rate for the state was 4.7 percent and for the nation was 4.4 percent.

TOTAL PERSONAL INCOME

In 2000 Bath had a total personal income (TPI) of \$212,051*. This TPI ranked 91st in the state and accounted for 0.2 percent of the state total. In 1990 the TPI of Bath was \$111,674* and ranked 98th in the state. The 2000 TPI reflected an increase of 12.6 percent from 1999. The 1999-2000 state change was 8.1 percent and the national change was 8.0 percent. The 1990-2000 average annual growth rate of TPI was 6.6 percent. The average annual growth rate for the state was 5.7 percent and for the nation was 5.6 percent.

COMPONENTS OF TOTAL PERSONAL INCOME

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of Bath. In 2000 net earnings accounted for 63.2 percent of TPI (compared with 62.7 in 1990); dividends, interest, and rent were 14.2 percent (compared with 14.3 in 1990); and personal current transfer receipts were 22.5 percent (compared with 23.0 in 1990). From 1999 to 2000 net earnings increased 16.1 percent; dividends, interest, and rent increased 6.6 percent; and personal current transfer receipts increased 7.4 percent. From 1990 to 2000 net earnings increased on average 6.7 percent each year; dividends, interest, and rent increased on average 6.5 percent; and personal current transfer receipts increased on average 6.4 percent.

EARNINGS BY PLACE OF WORK

Earnings of persons employed in Bath increased from \$64,215* in 1999 to \$74,585* in 2000, an increase of 16.1 percent. The 1999-2000 state change was 7.0 percent and the national change was 8.0 percent. The average annual growth rate from the 1990 estimate of \$42,519* to the 2000 estimate was 5.8 percent. The average annual growth rate for the state was 5.7 percent and for the nation was 5.8 percent.
