



BEARFACTS 1990 – 2000

Camden , North Carolina [37029]

Camden is one of 100 counties in North Carolina. It is part of the Elizabeth City, NC Micropolitan SA. Its 2000 population of 6,922 ranked 98th in the state.

PER CAPITA PERSONAL INCOME

In 2000 Camden had a per capita personal income (PCPI) of \$25,420. This PCPI ranked 27th in the state and was 94 percent of the state average, \$27,067, and 85 percent of the national average, \$29,847. The 2000 PCPI reflected an increase of 10.0 percent from 1999. The 1999-2000 state change was 5.9 percent and the national change was 6.8 percent. In 1990 the PCPI of Camden was \$13,755 and ranked 67th in the state. The 1990-2000 average annual growth rate of PCPI was 6.3 percent. The average annual growth rate for the state was 4.6 percent and for the nation was 4.4 percent.

TOTAL PERSONAL INCOME

In 2000 Camden had a total personal income (TPI) of \$175,954*. This TPI ranked 97th in the state and accounted for 0.1 percent of the state total. In 1990 the TPI of Camden was \$81,662* and ranked 97th in the state. The 2000 TPI reflected an increase of 12.0 percent from 1999. The 1999-2000 state change was 7.6 percent and the national change was 8.0 percent. The 1990-2000 average annual growth rate of TPI was 8.0 percent. The average annual growth rate for the state was 6.6 percent and for the nation was 5.6 percent.

COMPONENTS OF TOTAL PERSONAL INCOME

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of Camden. In 2000 net earnings accounted for 63.6 percent of TPI (compared with 63.2 in 1990); dividends, interest, and rent were 20.9 percent (compared with 21.0 in 1990); and personal current transfer receipts were 15.5 percent (compared with 15.9 in 1990). From 1999 to 2000 net earnings increased 11.7 percent; dividends, interest, and rent increased 17.6 percent; and personal current transfer receipts increased 6.4 percent. From 1990 to 2000 net earnings increased on average 8.1 percent each year; dividends, interest, and rent increased on average 7.9 percent; and personal current transfer receipts increased on average 7.7 percent.

EARNINGS BY PLACE OF WORK

Earnings of persons employed in Camden increased from \$49,717* in 1999 to \$53,435* in 2000, an increase of 7.5 percent. The 1999-2000 state change was 7.4 percent and the national change was 8.0 percent. The average annual growth rate from the 1990 estimate of \$24,472* to the 2000 estimate was 8.1 percent. The average annual growth rate for the state was 6.5 percent and for the nation was 5.8 percent.
