



BEARFACTS 1990 – 2000

Mathews , Virginia [51115]

Mathews is one of 105 counties in Virginia. It is part of the [Virginia Beach-Norfolk-Newport News, VA-NC \(MSA\)](#). Its 2000 population of 9,188 ranked 95th in the state.

PER CAPITA PERSONAL INCOME

In 2000 Mathews had a per capita personal income (PCPI) of \$30,564. This PCPI ranked 14th in the state and was 98 percent of the state average, \$31,086, and 102 percent of the national average, \$29,847. The 2000 PCPI reflected an increase of 10.2 percent from 1999. The 1999-2000 state change was 6.4 percent and the national change was 6.8 percent. In 1990 the PCPI of Mathews was \$19,311 and ranked 19th in the state. The 1990-2000 average annual growth rate of PCPI was 4.7 percent. The average annual growth rate for the state was 4.3 percent and for the nation was 4.4 percent.

TOTAL PERSONAL INCOME

In 2000 Mathews had a total personal income (TPI) of \$280,825*. This TPI ranked 87th in the state and accounted for 0.1 percent of the state total. In 1990 the TPI of Mathews was \$161,286* and ranked 85th in the state. The 2000 TPI reflected an increase of 9.8 percent from 1999. The 1999-2000 state change was 7.9 percent and the national change was 8.0 percent. The 1990-2000 average annual growth rate of TPI was 5.7 percent. The average annual growth rate for the state was 5.7 percent and for the nation was 5.6 percent.

COMPONENTS OF TOTAL PERSONAL INCOME

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of Mathews. In 2000 net earnings accounted for 58.5 percent of TPI (compared with 57.0 in 1990); dividends, interest, and rent were 26.4 percent (compared with 28.0 in 1990); and personal current transfer receipts were 15.1 percent (compared with 15.0 in 1990). From 1999 to 2000 net earnings increased 10.4 percent; dividends, interest, and rent increased 10.5 percent; and personal current transfer receipts increased 6.1 percent. From 1990 to 2000 net earnings increased on average 6.0 percent each year; dividends, interest, and rent increased on average 5.1 percent; and personal current transfer receipts increased on average 5.8 percent.

EARNINGS BY PLACE OF WORK

Earnings of persons employed in Mathews increased from \$52,055* in 1999 to \$56,305* in 2000, an increase of 8.2 percent. The 1999-2000 state change was 9.2 percent and the national change was 8.0 percent. The average annual growth rate from the 1990 estimate of \$34,442* to the 2000 estimate was 5.0 percent. The average annual growth rate for the state was 5.9 percent and for the nation was 5.8 percent.
