



BEARFACTS 1990 – 2000

Shreveport-Bossier City-Minden (BEA-EA) [57153]

Shreveport-Bossier City-Minden is one of 179 BEA Economic Areas in the nation. Its 2000 population of 539,359 ranked 107th in the nation.

PER CAPITA PERSONAL INCOME

In 2000 Shreveport-Bossier City-Minden had a per capita personal income (PCPI) of \$22,258. This PCPI ranked 146th in the United States and was 75 percent of the national average, \$29,847. The 2000 PCPI reflected an increase of 4.6 percent from 1999. The 1999-2000 national change was 6.8 percent. In 1990 the PCPI of Shreveport-Bossier City-Minden was \$14,828 and ranked 145th in the United States. The 1990-2000 average annual growth rate of PCPI was 4.1 percent. The average annual growth rate for the nation was 4.4 percent.

TOTAL PERSONAL INCOME

In 2000 Shreveport-Bossier City-Minden had a total personal income (TPI) of \$12,005,175*. This TPI ranked 114th in the United States. In 1990 the TPI of Shreveport-Bossier City-Minden was \$7,715,641* and ranked 108th in the United States. The 2000 TPI reflected an increase of 4.8 percent from 1999. The 1999-2000 national change was 8.0 percent. The 1990-2000 average annual growth rate of TPI was 4.5 percent. The average annual growth rate for the nation was 5.6 percent.

COMPONENTS OF TOTAL PERSONAL INCOME

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of Shreveport-Bossier City-Minden. In 2000 net earnings accounted for 63.2 percent of TPI (compared with 63.4 in 1990); dividends, interest, and rent were 18.2 percent (compared with 19.8 in 1990); and personal current transfer receipts were 18.5 percent (compared with 16.8 in 1990). From 1999 to 2000 net earnings increased 4.9 percent; dividends, interest, and rent increased 7.1 percent; and personal current transfer receipts increased 2.1 percent. From 1990 to 2000 net earnings increased on average 4.5 percent each year; dividends, interest, and rent increased on average 3.7 percent; and personal current transfer receipts increased on average 5.6 percent.

EARNINGS BY PLACE OF WORK

Earnings of persons employed in Shreveport-Bossier City-Minden increased from \$8,051,118* in 1999 to \$8,431,254* in 2000, an increase of 4.7 percent. The 1999-2000 national change was 8.0 percent. The average annual growth rate from the 1990 estimate of \$5,355,003* to the 2000 estimate was 4.6 percent. The average annual growth rate for the nation was 5.8 percent.
