



BEARFACTS 1991 – 2001 Greenlee , Arizona [04011]

Greenlee is one of 15 counties in Arizona. It is part of the Safford, AZ Micropolitan SA. Its 2001 population of 8,281 ranked 15th in the state.

PER CAPITA PERSONAL INCOME

In 2001 Greenlee had a per capita personal income (PCPI) of \$19,842. This PCPI ranked 6th in the state and was 76 percent of the state average, \$26,181, and 65 percent of the national average, \$30,582. The 2001 PCPI reflected a decrease of 1.8 percent from 2000. The 2000-2001 state change was 2.0 percent and the national change was 2.5 percent. In 1991 the PCPI of Greenlee was \$14,338 and ranked 8th in the state. The 1991-2001 average annual growth rate of PCPI was 3.3 percent. The average annual growth rate for the state was 4.3 percent and for the nation was 4.4 percent.

TOTAL PERSONAL INCOME

In 2001 Greenlee had a total personal income (TPI) of \$164,315*. This TPI ranked 15th in the state and accounted for 0.1 percent of the state total. In 1991 the TPI of Greenlee was \$118,505* and ranked 15th in the state. The 2001 TPI reflected a decrease of 4.8 percent from 2000. The 2000-2001 state change was 4.7 percent and the national change was 3.5 percent. The 1991-2001 average annual growth rate of TPI was 3.3 percent. The average annual growth rate for the state was 7.8 percent and for the nation was 5.6 percent.

COMPONENTS OF TOTAL PERSONAL INCOME

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of Greenlee. In 2001 net earnings accounted for 68.0 percent of TPI (compared with 69.4 in 1991); dividends, interest, and rent were 10.3 percent (compared with 13.4 in 1991); and personal current transfer receipts were 21.7 percent (compared with 17.1 in 1991). From 2000 to 2001 net earnings decreased 11.3 percent; dividends, interest, and rent increased 2.6 percent; and personal current transfer receipts increased 18.0 percent. From 1991 to 2001 net earnings increased on average 3.1 percent each year; dividends, interest, and rent increased on average 0.6 percent; and personal current transfer receipts increased on average 5.8 percent.

EARNINGS BY PLACE OF WORK

Earnings of persons employed in Greenlee decreased from \$211,353* in 2000 to \$192,673* in 2001, a decrease of 8.8 percent. The 2000-2001 state change was 4.4 percent and the national change was 3.1 percent. The average annual growth rate from the 1991 estimate of \$120,418* to the 2001 estimate was 4.8 percent. The average annual growth rate for the state was 8.4 percent and for the nation was 5.8 percent.
