



BEARFACTS 1991 – 2001

Flagler , Florida [12035]

Flagler is one of 67 counties in Florida. It is part of the [Palm Coast, FL \(MSA\)](#). Its 2001 population of 53,695 ranked 40th in the state.

PER CAPITA PERSONAL INCOME

In 2001 Flagler had a per capita personal income (PCPI) of \$23,892. This PCPI ranked 31st in the state and was 82 percent of the state average, \$29,291, and 78 percent of the national average, \$30,582. The 2001 PCPI reflected an increase of 1.1 percent from 2000. The 2000-2001 state change was 2.7 percent and the national change was 2.5 percent. In 1991 the PCPI of Flagler was \$15,748 and ranked 33rd in the state. The 1991-2001 average annual growth rate of PCPI was 4.3 percent. The average annual growth rate for the state was 4.0 percent and for the nation was 4.4 percent.

TOTAL PERSONAL INCOME

In 2001 Flagler had a total personal income (TPI) of \$1,282,887*. This TPI ranked 38th in the state and accounted for 0.3 percent of the state total. In 1991 the TPI of Flagler was \$496,023* and ranked 41st in the state. The 2001 TPI reflected an increase of 7.4 percent from 2000. The 2000-2001 state change was 4.6 percent and the national change was 3.5 percent. The 1991-2001 average annual growth rate of TPI was 10.0 percent. The average annual growth rate for the state was 6.1 percent and for the nation was 5.6 percent.

COMPONENTS OF TOTAL PERSONAL INCOME

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of Flagler. In 2001 net earnings accounted for 41.5 percent of TPI (compared with 48.3 in 1991); dividends, interest, and rent were 36.0 percent (compared with 30.6 in 1991); and personal current transfer receipts were 22.5 percent (compared with 21.1 in 1991). From 2000 to 2001 net earnings increased 2.4 percent; dividends, interest, and rent increased 11.1 percent; and personal current transfer receipts increased 11.6 percent. From 1991 to 2001 net earnings increased on average 8.3 percent each year; dividends, interest, and rent increased on average 11.8 percent; and personal current transfer receipts increased on average 10.7 percent.

EARNINGS BY PLACE OF WORK

Earnings of persons employed in Flagler increased from \$395,892* in 2000 to \$431,417* in 2001, an increase of 9.0 percent. The 2000-2001 state change was 3.9 percent and the national change was 3.1 percent. The average annual growth rate from the 1991 estimate of \$172,266* to the 2001 estimate was 9.6 percent. The average annual growth rate for the state was 6.5 percent and for the nation was 5.8 percent.
