



BEARFACTS 1991 – 2001

Quitman , Georgia [13239]

Quitman is one of 159 counties in Georgia. It is part of the Eufaula, AL-GA Micropolitan SA. Its 2001 population of 2,630 ranked 156th in the state.

PER CAPITA PERSONAL INCOME

In 2001 Quitman had a per capita personal income (PCPI) of \$19,979. This PCPI ranked 110th in the state and was 70 percent of the state average, \$28,582, and 65 percent of the national average, \$30,582. The 2001 PCPI reflected an increase of 7.0 percent from 2000. The 2000-2001 state change was 2.1 percent and the national change was 2.5 percent. In 1991 the PCPI of Quitman was \$12,993 and ranked 123rd in the state. The 1991-2001 average annual growth rate of PCPI was 4.4 percent. The average annual growth rate for the state was 4.7 percent and for the nation was 4.4 percent.

TOTAL PERSONAL INCOME

In 2001 Quitman had a total personal income (TPI) of \$52,545*. This TPI ranked 157th in the state and accounted for 0.0 percent of the state total. In 1991 the TPI of Quitman was \$29,274* and ranked 158th in the state. The 2001 TPI reflected an increase of 8.1 percent from 2000. The 2000-2001 state change was 4.5 percent and the national change was 3.5 percent. The 1991-2001 average annual growth rate of TPI was 6.0 percent. The average annual growth rate for the state was 7.2 percent and for the nation was 5.6 percent.

COMPONENTS OF TOTAL PERSONAL INCOME

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of Quitman. In 2001 net earnings accounted for 54.9 percent of TPI (compared with 53.4 in 1991); dividends, interest, and rent were 15.9 percent (compared with 17.9 in 1991); and personal current transfer receipts were 29.2 percent (compared with 28.7 in 1991). From 2000 to 2001 net earnings increased 4.2 percent; dividends, interest, and rent increased 10.4 percent; and personal current transfer receipts increased 14.9 percent. From 1991 to 2001 net earnings increased on average 6.3 percent each year; dividends, interest, and rent increased on average 4.8 percent; and personal current transfer receipts increased on average 6.2 percent.

EARNINGS BY PLACE OF WORK

Earnings of persons employed in Quitman increased from \$8,984* in 2000 to \$10,192* in 2001, an increase of 13.4 percent. The 2000-2001 state change was 3.8 percent and the national change was 3.1 percent. The average annual growth rate from the 1991 estimate of \$6,129* to the 2001 estimate was 5.2 percent. The average annual growth rate for the state was 7.4 percent and for the nation was 5.8 percent.
