



BEARFACTS 1991 – 2001

Camas , Idaho [16025]

Camas is one of 44 counties in Idaho. It is not part of a Metropolitan Area. Its 2001 population of 1,006 ranked 43rd in the state.

PER CAPITA PERSONAL INCOME

In 2001 Camas had a per capita personal income (PCPI) of \$22,730. This PCPI ranked 14th in the state and was 91 percent of the state average, \$25,027, and 74 percent of the national average, \$30,582. The 2001 PCPI reflected an increase of 6.3 percent from 2000. The 2000-2001 state change was 3.9 percent and the national change was 2.5 percent. In 1991 the PCPI of Camas was \$13,163 and ranked 32nd in the state. The 1991-2001 average annual growth rate of PCPI was 5.6 percent. The average annual growth rate for the state was 4.6 percent and for the nation was 4.4 percent.

TOTAL PERSONAL INCOME

In 2001 Camas had a total personal income (TPI) of \$22,866*. This TPI ranked 44th in the state and accounted for 0.1 percent of the state total. In 1991 the TPI of Camas was \$10,096* and ranked 44th in the state. The 2001 TPI reflected an increase of 9.4 percent from 2000. The 2000-2001 state change was 5.6 percent and the national change was 3.5 percent. The 1991-2001 average annual growth rate of TPI was 8.5 percent. The average annual growth rate for the state was 7.1 percent and for the nation was 5.6 percent.

COMPONENTS OF TOTAL PERSONAL INCOME

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of Camas. In 2001 net earnings accounted for 66.4 percent of TPI (compared with 53.7 in 1991); dividends, interest, and rent were 21.4 percent (compared with 30.0 in 1991); and personal current transfer receipts were 12.2 percent (compared with 16.4 in 1991). From 2000 to 2001 net earnings increased 11.6 percent; dividends, interest, and rent remained unchanged; and personal current transfer receipts increased 15.7 percent. From 1991 to 2001 net earnings increased on average 10.9 percent each year; dividends, interest, and rent increased on average 4.9 percent; and personal current transfer receipts increased on average 5.3 percent.

EARNINGS BY PLACE OF WORK

Earnings of persons employed in Camas increased from \$9,024* in 2000 to \$10,223* in 2001, an increase of 13.3 percent. The 2000-2001 state change was 4.4 percent and the national change was 3.1 percent. The average annual growth rate from the 1991 estimate of \$4,241* to the 2001 estimate was 9.2 percent. The average annual growth rate for the state was 6.9 percent and for the nation was 5.8 percent.
