



BEARFACTS 1991 – 2001

Lee , Illinois [17103]

Lee is one of 102 counties in Illinois. It is part of the Dixon, IL Micropolitan SA. Its 2001 population of 35,916 ranked 40th in the state.

PER CAPITA PERSONAL INCOME

In 2001 Lee had a per capita personal income (PCPI) of \$23,223. This PCPI ranked 63rd in the state and was 71 percent of the state average, \$32,553, and 76 percent of the national average, \$30,582. The 2001 PCPI reflected an increase of 0.4 percent from 2000. The 2000-2001 state change was 1.1 percent and the national change was 2.5 percent. In 1991 the PCPI of Lee was \$15,347 and ranked 65th in the state. The 1991-2001 average annual growth rate of PCPI was 4.2 percent. The average annual growth rate for the state was 4.4 percent and for the nation was 4.4 percent.

TOTAL PERSONAL INCOME

In 2001 Lee had a total personal income (TPI) of \$834,061*. This TPI ranked 45th in the state and accounted for 0.2 percent of the state total. In 1991 the TPI of Lee was \$532,716* and ranked 45th in the state. The 2001 TPI remained unchanged from 2000. The 2000-2001 state change was 1.7 percent and the national change was 3.5 percent. The 1991-2001 average annual growth rate of TPI was 4.6 percent. The average annual growth rate for the state was 5.2 percent and for the nation was 5.6 percent.

COMPONENTS OF TOTAL PERSONAL INCOME

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of Lee. In 2001 net earnings accounted for 60.4 percent of TPI (compared with 60.1 in 1991); dividends, interest, and rent were 22.2 percent (compared with 23.7 in 1991); and personal current transfer receipts were 17.4 percent (compared with 16.2 in 1991). From 2000 to 2001 net earnings decreased 1.8 percent; dividends, interest, and rent decreased 0.2 percent; and personal current transfer receipts increased 6.8 percent. From 1991 to 2001 net earnings increased on average 4.6 percent each year; dividends, interest, and rent increased on average 3.9 percent; and personal current transfer receipts increased on average 5.4 percent.

EARNINGS BY PLACE OF WORK

Earnings of persons employed in Lee decreased from \$507,051* in 2000 to \$501,651* in 2001, a decrease of 1.1 percent. The 2000-2001 state change was 1.6 percent and the national change was 3.1 percent. The average annual growth rate from the 1991 estimate of \$321,928* to the 2001 estimate was 4.5 percent. The average annual growth rate for the state was 5.3 percent and for the nation was 5.8 percent.
