



BEARFACTS 1991 – 2001 Hickman , Kentucky [21105]

Hickman is one of 120 counties in Kentucky. It is not part of a Metropolitan Area. Its 2001 population of 5,234 ranked 118th in the state.

PER CAPITA PERSONAL INCOME

In 2001 Hickman had a per capita personal income (PCPI) of \$32,631. This PCPI ranked 3rd in the state and was 131 percent of the state average, \$24,923, and 107 percent of the national average, \$30,582. The 2001 PCPI reflected an increase of 8.1 percent from 2000. The 2000-2001 state change was 2.1 percent and the national change was 2.5 percent. In 1991 the PCPI of Hickman was \$13,568 and ranked 57th in the state. The 1991-2001 average annual growth rate of PCPI was 9.2 percent. The average annual growth rate for the state was 4.4 percent and for the nation was 4.4 percent.

TOTAL PERSONAL INCOME

In 2001 Hickman had a total personal income (TPI) of \$170,791*. This TPI ranked 107th in the state and accounted for 0.2 percent of the state total. In 1991 the TPI of Hickman was \$76,186* and ranked 112th in the state. The 2001 TPI reflected an increase of 7.9 percent from 2000. The 2000-2001 state change was 2.5 percent and the national change was 3.5 percent. The 1991-2001 average annual growth rate of TPI was 8.4 percent. The average annual growth rate for the state was 5.4 percent and for the nation was 5.6 percent.

COMPONENTS OF TOTAL PERSONAL INCOME

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of Hickman. In 2001 net earnings accounted for 73.6 percent of TPI (compared with 56.7 in 1991); dividends, interest, and rent were 11.1 percent (compared with 20.8 in 1991); and personal current transfer receipts were 15.3 percent (compared with 22.5 in 1991). From 2000 to 2001 net earnings increased 8.5 percent; dividends, interest, and rent increased 4.9 percent; and personal current transfer receipts increased 7.0 percent. From 1991 to 2001 net earnings increased on average 11.3 percent each year; dividends, interest, and rent increased on average 1.8 percent; and personal current transfer receipts increased on average 4.3 percent.

EARNINGS BY PLACE OF WORK

Earnings of persons employed in Hickman increased from \$98,318* in 2000 to \$106,182* in 2001, an increase of 8.0 percent. The 2000-2001 state change was 2.1 percent and the national change was 3.1 percent. The average annual growth rate from the 1991 estimate of \$32,742* to the 2001 estimate was 12.5 percent. The average annual growth rate for the state was 5.5 percent and for the nation was 5.8 percent.
