



BEARFACTS 1991 – 2001

Leslie , Kentucky [21131]

Leslie is one of 120 counties in Kentucky. It is not part of a Metropolitan Area. Its 2001 population of 12,200 ranked 90th in the state.

PER CAPITA PERSONAL INCOME

In 2001 Leslie had a per capita personal income (PCPI) of \$17,437. This PCPI ranked 94th in the state and was 70 percent of the state average, \$24,923, and 57 percent of the national average, \$30,582. The 2001 PCPI reflected an increase of 5.7 percent from 2000. The 2000-2001 state change was 2.1 percent and the national change was 2.5 percent. In 1991 the PCPI of Leslie was \$10,575 and ranked 103rd in the state. The 1991-2001 average annual growth rate of PCPI was 5.1 percent. The average annual growth rate for the state was 4.4 percent and for the nation was 4.4 percent.

TOTAL PERSONAL INCOME

In 2001 Leslie had a total personal income (TPI) of \$212,734*. This TPI ranked 93rd in the state and accounted for 0.2 percent of the state total. In 1991 the TPI of Leslie was \$142,658* and ranked 85th in the state. The 2001 TPI reflected an increase of 4.3 percent from 2000. The 2000-2001 state change was 2.5 percent and the national change was 3.5 percent. The 1991-2001 average annual growth rate of TPI was 4.1 percent. The average annual growth rate for the state was 5.4 percent and for the nation was 5.6 percent.

COMPONENTS OF TOTAL PERSONAL INCOME

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of Leslie. In 2001 net earnings accounted for 51.3 percent of TPI (compared with 58.1 in 1991); dividends, interest, and rent were 8.8 percent (compared with 8.9 in 1991); and personal current transfer receipts were 39.9 percent (compared with 32.9 in 1991). From 2000 to 2001 net earnings increased 3.3 percent; dividends, interest, and rent increased 3.9 percent; and personal current transfer receipts increased 5.5 percent. From 1991 to 2001 net earnings increased on average 2.8 percent each year; dividends, interest, and rent increased on average 3.9 percent; and personal current transfer receipts increased on average 6.1 percent.

EARNINGS BY PLACE OF WORK

Earnings of persons employed in Leslie decreased from \$130,504* in 2000 to \$114,755* in 2001, a decrease of 12.1 percent. The 2000-2001 state change was 2.1 percent and the national change was 3.1 percent. The average annual growth rate from the 1991 estimate of \$94,996* to the 2001 estimate was 1.9 percent. The average annual growth rate for the state was 5.5 percent and for the nation was 5.8 percent.
