



BEARFACTS 1991 – 2001

Rockcastle , Kentucky [21203]

Rockcastle is one of 120 counties in Kentucky. It is part of the Richmond-Berea, KY Micropolitan SA. Its 2001 population of 16,522 ranked 67th in the state.

PER CAPITA PERSONAL INCOME

In 2001 Rockcastle had a per capita personal income (PCPI) of \$16,041. This PCPI ranked 111th in the state and was 64 percent of the state average, \$24,923, and 52 percent of the national average, \$30,582. The 2001 PCPI reflected an increase of 2.0 percent from 2000. The 2000-2001 state change was 2.1 percent and the national change was 2.5 percent. In 1991 the PCPI of Rockcastle was \$10,862 and ranked 101st in the state. The 1991-2001 average annual growth rate of PCPI was 4.0 percent. The average annual growth rate for the state was 4.4 percent and for the nation was 4.4 percent.

TOTAL PERSONAL INCOME

In 2001 Rockcastle had a total personal income (TPI) of \$265,036*. This TPI ranked 79th in the state and accounted for 0.3 percent of the state total. In 1991 the TPI of Rockcastle was \$163,364* and ranked 74th in the state. The 2001 TPI reflected an increase of 1.3 percent from 2000. The 2000-2001 state change was 2.5 percent and the national change was 3.5 percent. The 1991-2001 average annual growth rate of TPI was 5.0 percent. The average annual growth rate for the state was 5.4 percent and for the nation was 5.6 percent.

COMPONENTS OF TOTAL PERSONAL INCOME

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of Rockcastle. In 2001 net earnings accounted for 57.9 percent of TPI (compared with 60.4 in 1991); dividends, interest, and rent were 12.5 percent (compared with 11.8 in 1991); and personal current transfer receipts were 29.6 percent (compared with 27.7 in 1991). From 2000 to 2001 net earnings decreased 2.0 percent; dividends, interest, and rent increased 5.5 percent; and personal current transfer receipts increased 6.6 percent. From 1991 to 2001 net earnings increased on average 4.5 percent each year; dividends, interest, and rent increased on average 5.5 percent; and personal current transfer receipts increased on average 5.7 percent.

EARNINGS BY PLACE OF WORK

Earnings of persons employed in Rockcastle decreased from \$105,390* in 2000 to \$101,692* in 2001, a decrease of 3.5 percent. The 2000-2001 state change was 2.1 percent and the national change was 3.1 percent. The average annual growth rate from the 1991 estimate of \$72,271* to the 2001 estimate was 3.5 percent. The average annual growth rate for the state was 5.5 percent and for the nation was 5.8 percent.
