



BEARFACTS 1991 – 2001

Wolfe , Kentucky [21237]

Wolfe is one of 120 counties in Kentucky. It is not part of a Metropolitan Area. Its 2001 population of 6,910 ranked 113th in the state.

PER CAPITA PERSONAL INCOME

In 2001 Wolfe had a per capita personal income (PCPI) of \$16,034. This PCPI ranked 112th in the state and was 64 percent of the state average, \$24,923, and 52 percent of the national average, \$30,582. The 2001 PCPI reflected an increase of 4.0 percent from 2000. The 2000-2001 state change was 2.1 percent and the national change was 2.5 percent. In 1991 the PCPI of Wolfe was \$10,269 and ranked 107th in the state. The 1991-2001 average annual growth rate of PCPI was 4.6 percent. The average annual growth rate for the state was 4.4 percent and for the nation was 4.4 percent.

TOTAL PERSONAL INCOME

In 2001 Wolfe had a total personal income (TPI) of \$110,792*. This TPI ranked 116th in the state and accounted for 0.1 percent of the state total. In 1991 the TPI of Wolfe was \$68,522* and ranked 115th in the state. The 2001 TPI reflected an increase of 1.3 percent from 2000. The 2000-2001 state change was 2.5 percent and the national change was 3.5 percent. The 1991-2001 average annual growth rate of TPI was 4.9 percent. The average annual growth rate for the state was 5.4 percent and for the nation was 5.6 percent.

COMPONENTS OF TOTAL PERSONAL INCOME

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of Wolfe. In 2001 net earnings accounted for 45.9 percent of TPI (compared with 46.8 in 1991); dividends, interest, and rent were 9.5 percent (compared with 13.3 in 1991); and personal current transfer receipts were 44.6 percent (compared with 39.9 in 1991). From 2000 to 2001 net earnings decreased 1.9 percent; dividends, interest, and rent increased 6.9 percent; and personal current transfer receipts increased 3.7 percent. From 1991 to 2001 net earnings increased on average 4.7 percent each year; dividends, interest, and rent increased on average 1.4 percent; and personal current transfer receipts increased on average 6.1 percent.

EARNINGS BY PLACE OF WORK

Earnings of persons employed in Wolfe decreased from \$44,102* in 2000 to \$38,036* in 2001, a decrease of 13.8 percent. The 2000-2001 state change was 2.1 percent and the national change was 3.1 percent. The average annual growth rate from the 1991 estimate of \$27,655* to the 2001 estimate was 3.2 percent. The average annual growth rate for the state was 5.5 percent and for the nation was 5.8 percent.
