



BEARFACTS 1991 – 2001 Carroll , Mississippi [28015]

Carroll is one of 82 counties in Mississippi. It is part of the Greenwood, MS Micropolitan SA. Its 2001 population of 10,657 ranked 71st in the state.

PER CAPITA PERSONAL INCOME

In 2001 Carroll had a per capita personal income (PCPI) of \$19,317. This PCPI ranked 38th in the state and was 88 percent of the state average, \$21,990, and 63 percent of the national average, \$30,582. The 2001 PCPI reflected an increase of 7.2 percent from 2000. The 2000-2001 state change was 4.7 percent and the national change was 2.5 percent. In 1991 the PCPI of Carroll was \$11,509 and ranked 57th in the state. The 1991-2001 average annual growth rate of PCPI was 5.3 percent. The average annual growth rate for the state was 4.8 percent and for the nation was 4.4 percent.

TOTAL PERSONAL INCOME

In 2001 Carroll had a total personal income (TPI) of \$205,862*. This TPI ranked 67th in the state and accounted for 0.3 percent of the state total. In 1991 the TPI of Carroll was \$108,183* and ranked 72nd in the state. The 2001 TPI reflected an increase of 6.1 percent from 2000. The 2000-2001 state change was 4.8 percent and the national change was 3.5 percent. The 1991-2001 average annual growth rate of TPI was 6.6 percent. The average annual growth rate for the state was 5.8 percent and for the nation was 5.6 percent.

COMPONENTS OF TOTAL PERSONAL INCOME

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of Carroll. In 2001 net earnings accounted for 63.6 percent of TPI (compared with 66.3 in 1991); dividends, interest, and rent were 15.4 percent (compared with 13.6 in 1991); and personal current transfer receipts were 21.0 percent (compared with 20.2 in 1991). From 2000 to 2001 net earnings increased 4.9 percent; dividends, interest, and rent increased 5.0 percent; and personal current transfer receipts increased 10.6 percent. From 1991 to 2001 net earnings increased on average 6.2 percent each year; dividends, interest, and rent increased on average 8.0 percent; and personal current transfer receipts increased on average 7.1 percent.

EARNINGS BY PLACE OF WORK

Earnings of persons employed in Carroll increased from \$37,778* in 2000 to \$49,601* in 2001, an increase of 31.3 percent. The 2000-2001 state change was 3.0 percent and the national change was 3.1 percent. The average annual growth rate from the 1991 estimate of \$28,864* to the 2001 estimate was 5.6 percent. The average annual growth rate for the state was 5.6 percent and for the nation was 5.8 percent.
