



BEARFACTS 1991 – 2001

Merrimack , New Hampshire [33013]

Merrimack is one of 10 counties in New Hampshire. It is part of the Concord, NH Micropolitan SA. Its 2001 population of 138,597 ranked 3rd in the state.

PER CAPITA PERSONAL INCOME

In 2001 Merrimack had a per capita personal income (PCPI) of \$31,669. This PCPI ranked 5th in the state and was 93 percent of the state average, \$33,919, and 104 percent of the national average, \$30,582. The 2001 PCPI reflected an increase of 2.4 percent from 2000. The 2000-2001 state change was 1.6 percent and the national change was 2.5 percent. In 1991 the PCPI of Merrimack was \$21,030 and ranked 4th in the state. The 1991-2001 average annual growth rate of PCPI was 4.2 percent. The average annual growth rate for the state was 4.8 percent and for the nation was 4.4 percent.

TOTAL PERSONAL INCOME

In 2001 Merrimack had a total personal income (TPI) of \$4,389,243*. This TPI ranked 3rd in the state and accounted for 10.3 percent of the state total. In 1991 the TPI of Merrimack was \$2,552,452* and ranked 3rd in the state. The 2001 TPI reflected an increase of 3.9 percent from 2000. The 2000-2001 state change was 2.9 percent and the national change was 3.5 percent. The 1991-2001 average annual growth rate of TPI was 5.6 percent. The average annual growth rate for the state was 6.1 percent and for the nation was 5.6 percent.

COMPONENTS OF TOTAL PERSONAL INCOME

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of Merrimack. In 2001 net earnings accounted for 70.5 percent of TPI (compared with 66.3 in 1991); dividends, interest, and rent were 17.6 percent (compared with 20.5 in 1991); and personal current transfer receipts were 11.8 percent (compared with 13.2 in 1991). From 2000 to 2001 net earnings increased 4.2 percent; dividends, interest, and rent decreased 0.3 percent; and personal current transfer receipts increased 8.4 percent. From 1991 to 2001 net earnings increased on average 6.2 percent each year; dividends, interest, and rent increased on average 4.0 percent; and personal current transfer receipts increased on average 4.4 percent.

EARNINGS BY PLACE OF WORK

Earnings of persons employed in Merrimack increased from \$3,168,883* in 2000 to \$3,342,854* in 2001, an increase of 5.5 percent. The 2000-2001 state change was 3.2 percent and the national change was 3.1 percent. The average annual growth rate from the 1991 estimate of \$1,770,953* to the 2001 estimate was 6.6 percent. The average annual growth rate for the state was 6.8 percent and for the nation was 5.8 percent.
