



BEARFACTS 1991 – 2001

Person , North Carolina [37145]

Person is one of 100 counties in North Carolina. It is part of the [Durham-Chapel Hill, NC \(MSA\)](#). Its 2001 population of 35,897 ranked 62nd in the state.

PER CAPITA PERSONAL INCOME

In 2001 Person had a per capita personal income (PCPI) of \$23,414. This PCPI ranked 49th in the state and was 85 percent of the state average, \$27,487, and 77 percent of the national average, \$30,582. The 2001 PCPI reflected an increase of 1.6 percent from 2000. The 2000-2001 state change was 1.6 percent and the national change was 2.5 percent. In 1991 the PCPI of Person was \$15,436 and ranked 49th in the state. The 1991-2001 average annual growth rate of PCPI was 4.3 percent. The average annual growth rate for the state was 4.5 percent and for the nation was 4.4 percent.

TOTAL PERSONAL INCOME

In 2001 Person had a total personal income (TPI) of \$840,495*. This TPI ranked 63rd in the state and accounted for 0.4 percent of the state total. In 1991 the TPI of Person was \$476,138* and ranked 61st in the state. The 2001 TPI reflected an increase of 2.1 percent from 2000. The 2000-2001 state change was 3.1 percent and the national change was 3.5 percent. The 1991-2001 average annual growth rate of TPI was 5.8 percent. The average annual growth rate for the state was 6.5 percent and for the nation was 5.6 percent.

COMPONENTS OF TOTAL PERSONAL INCOME

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of Person. In 2001 net earnings accounted for 66.7 percent of TPI (compared with 66.7 in 1991); dividends, interest, and rent were 13.9 percent (compared with 15.8 in 1991); and personal current transfer receipts were 19.4 percent (compared with 17.5 in 1991). From 2000 to 2001 net earnings decreased 0.4 percent; dividends, interest, and rent remained unchanged; and personal current transfer receipts increased 13.2 percent. From 1991 to 2001 net earnings increased on average 5.8 percent each year; dividends, interest, and rent increased on average 4.5 percent; and personal current transfer receipts increased on average 7.0 percent.

EARNINGS BY PLACE OF WORK

Earnings of persons employed in Person decreased from \$452,814* in 2000 to \$427,404* in 2001, a decrease of 5.6 percent. The 2000-2001 state change was 2.7 percent and the national change was 3.1 percent. The average annual growth rate from the 1991 estimate of \$288,223* to the 2001 estimate was 4.0 percent. The average annual growth rate for the state was 6.4 percent and for the nation was 5.8 percent.
