



BEARFACTS 1991 – 2001

Perry , Ohio [39127]

Perry is one of 88 counties in Ohio. It is not part of a Metropolitan Area. Its 2001 population of 34,296 ranked 69th in the state.

PER CAPITA PERSONAL INCOME

In 2001 Perry had a per capita personal income (PCPI) of \$18,704. This PCPI ranked 86th in the state and was 65 percent of the state average, \$28,585, and 61 percent of the national average, \$30,582. The 2001 PCPI reflected an increase of 1.6 percent from 2000. The 2000-2001 state change was 1.3 percent and the national change was 2.5 percent. In 1991 the PCPI of Perry was \$12,581 and ranked 83rd in the state. The 1991-2001 average annual growth rate of PCPI was 4.0 percent. The average annual growth rate for the state was 4.1 percent and for the nation was 4.4 percent.

TOTAL PERSONAL INCOME

In 2001 Perry had a total personal income (TPI) of \$641,485*. This TPI ranked 77th in the state and accounted for 0.2 percent of the state total. In 1991 the TPI of Perry was \$399,012* and ranked 74th in the state. The 2001 TPI reflected an increase of 2.2 percent from 2000. The 2000-2001 state change was 1.6 percent and the national change was 3.5 percent. The 1991-2001 average annual growth rate of TPI was 4.9 percent. The average annual growth rate for the state was 4.5 percent and for the nation was 5.6 percent.

COMPONENTS OF TOTAL PERSONAL INCOME

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of Perry. In 2001 net earnings accounted for 64.9 percent of TPI (compared with 61.5 in 1991); dividends, interest, and rent were 11.1 percent (compared with 14.7 in 1991); and personal current transfer receipts were 24.0 percent (compared with 23.9 in 1991). From 2000 to 2001 net earnings remained unchanged; dividends, interest, and rent decreased 0.2 percent; and personal current transfer receipts increased 9.9 percent. From 1991 to 2001 net earnings increased on average 5.4 percent each year; dividends, interest, and rent increased on average 2.0 percent; and personal current transfer receipts increased on average 4.9 percent.

EARNINGS BY PLACE OF WORK

Earnings of persons employed in Perry decreased from \$242,259* in 2000 to \$236,766* in 2001, a decrease of 2.3 percent. The 2000-2001 state change was 1.3 percent and the national change was 3.1 percent. The average annual growth rate from the 1991 estimate of \$164,833* to the 2001 estimate was 3.7 percent. The average annual growth rate for the state was 4.7 percent and for the nation was 5.8 percent.
