



BEARFACTS 1991 – 2001

San Francisco-Oakland-Fremont (MSA) [41860]

San Francisco-Oakland-Fremont is one of 363 Metropolitan Statistical Areas (MSAs) in the nation. Its 2001 population of 4,181,279 ranked 12th in the nation.

PER CAPITA PERSONAL INCOME

In 2001 San Francisco-Oakland-Fremont had a per capita personal income (PCPI) of \$47,681. This PCPI ranked 3rd in the United States and was 156 percent of the national average, \$30,582. The 2001 PCPI reflected a decrease of 1.4 percent from 2000. The 2000-2001 national change was 2.5 percent. In 1991 the PCPI of San Francisco-Oakland-Fremont was \$27,443 and ranked 3rd in the United States. The 1991-2001 average annual growth rate of PCPI was 5.7 percent. The average annual growth rate for the nation was 4.4 percent.

TOTAL PERSONAL INCOME

In 2001 San Francisco-Oakland-Fremont had a total personal income (TPI) of \$199,369,271*. This TPI ranked 6th in the United States. In 1991 the TPI of San Francisco-Oakland-Fremont was \$103,194,317* and ranked 7th in the United States. The 2001 TPI reflected a decrease of 0.3 percent from 2000. The 2000-2001 national change was 3.5 percent. The 1991-2001 average annual growth rate of TPI was 6.8 percent. The average annual growth rate for the nation was 5.6 percent.

COMPONENTS OF TOTAL PERSONAL INCOME

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of San Francisco-Oakland-Fremont. In 2001 net earnings accounted for 72.8 percent of TPI (compared with 68.6 in 1991); dividends, interest, and rent were 19.1 percent (compared with 21.9 in 1991); and personal current transfer receipts were 8.1 percent (compared with 9.5 in 1991). From 2000 to 2001 net earnings decreased 1.8 percent; dividends, interest, and rent increased 1.1 percent; and personal current transfer receipts increased 11.0 percent. From 1991 to 2001 net earnings increased on average 7.4 percent each year; dividends, interest, and rent increased on average 5.4 percent; and personal current transfer receipts increased on average 5.1 percent.

EARNINGS BY PLACE OF WORK

Earnings of persons employed in San Francisco-Oakland-Fremont remained unchanged. The 2000-2001 national change was 3.1 percent. The average annual growth rate from the 1991 estimate of \$81,616,823* to the 2001 estimate was 7.0 percent. The average annual growth rate for the nation was 5.8 percent.
