



BEARFACTS 1991 – 2001

Snyder , Pennsylvania [42109]

Snyder is one of 67 counties in Pennsylvania. It is part of the Selinsgrove, PA Micropolitan SA. Its 2001 population of 37,744 ranked 57th in the state.

PER CAPITA PERSONAL INCOME

In 2001 Snyder had a per capita personal income (PCPI) of \$25,278. This PCPI ranked 25th in the state and was 83 percent of the state average, \$30,310, and 83 percent of the national average, \$30,582. The 2001 PCPI reflected an increase of 0.9 percent from 2000. The 2000-2001 state change was 2.1 percent and the national change was 2.5 percent. In 1991 the PCPI of Snyder was \$17,670 and ranked 22nd in the state. The 1991-2001 average annual growth rate of PCPI was 3.6 percent. The average annual growth rate for the state was 4.1 percent and for the nation was 4.4 percent.

TOTAL PERSONAL INCOME

In 2001 Snyder had a total personal income (TPI) of \$954,090*. This TPI ranked 53rd in the state and accounted for 0.3 percent of the state total. In 1991 the TPI of Snyder was \$653,967* and ranked 49th in the state. The 2001 TPI reflected an increase of 1.5 percent from 2000. The 2000-2001 state change was 2.1 percent and the national change was 3.5 percent. The 1991-2001 average annual growth rate of TPI was 3.8 percent. The average annual growth rate for the state was 4.4 percent and for the nation was 5.6 percent.

COMPONENTS OF TOTAL PERSONAL INCOME

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of Snyder. In 2001 net earnings accounted for 57.8 percent of TPI (compared with 55.5 in 1991); dividends, interest, and rent were 17.9 percent (compared with 18.6 in 1991); and personal current transfer receipts were 24.3 percent (compared with 26.0 in 1991). From 2000 to 2001 net earnings increased 0.6 percent; dividends, interest, and rent decreased 1.3 percent; and personal current transfer receipts increased 5.8 percent. From 1991 to 2001 net earnings increased on average 4.3 percent each year; dividends, interest, and rent increased on average 3.4 percent; and personal current transfer receipts increased on average 3.2 percent.

EARNINGS BY PLACE OF WORK

Earnings of persons employed in Snyder increased from \$610,204* in 2000 to \$621,016* in 2001, an increase of 1.8 percent. The 2000-2001 state change was 2.0 percent and the national change was 3.1 percent. The average annual growth rate from the 1991 estimate of \$399,129* to the 2001 estimate was 4.5 percent. The average annual growth rate for the state was 4.5 percent and for the nation was 5.8 percent.
