



## **BEARFACTS 1991 – 2001**

### **Bon Homme , South Dakota [46009]**

Bon Homme is one of 66 counties in South Dakota. It is not part of a Metropolitan Area. Its 2001 population of 7,179 ranked 27th in the state.

#### **PER CAPITA PERSONAL INCOME**

In 2001 Bon Homme had a per capita personal income (PCPI) of \$22,959. This PCPI ranked 48th in the state and was 85 percent of the state average, \$26,927, and 75 percent of the national average, \$30,582. The 2001 PCPI reflected an increase of 4.6 percent from 2000. The 2000-2001 state change was 4.7 percent and the national change was 2.5 percent. In 1991 the PCPI of Bon Homme was \$14,030 and ranked 51st in the state. The 1991-2001 average annual growth rate of PCPI was 5.0 percent. The average annual growth rate for the state was 4.8 percent and for the nation was 4.4 percent.

#### **TOTAL PERSONAL INCOME**

In 2001 Bon Homme had a total personal income (TPI) of \$164,826\*. This TPI ranked 26th in the state and accounted for 0.8 percent of the state total. In 1991 the TPI of Bon Homme was \$99,077\* and ranked 27th in the state. The 2001 TPI reflected an increase of 3.6 percent from 2000. The 2000-2001 state change was 5.1 percent and the national change was 3.5 percent. The 1991-2001 average annual growth rate of TPI was 5.2 percent. The average annual growth rate for the state was 5.6 percent and for the nation was 5.6 percent.

#### **COMPONENTS OF TOTAL PERSONAL INCOME**

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of Bon Homme. In 2001 net earnings accounted for 52.4 percent of TPI (compared with 52.2 in 1991); dividends, interest, and rent were 29.5 percent (compared with 29.8 in 1991); and personal current transfer receipts were 18.1 percent (compared with 18.0 in 1991). From 2000 to 2001 net earnings decreased 1.4 percent; dividends, interest, and rent increased 11.7 percent; and personal current transfer receipts increased 6.9 percent. From 1991 to 2001 net earnings increased on average 5.3 percent each year; dividends, interest, and rent increased on average 5.1 percent; and personal current transfer receipts increased on average 5.3 percent.

#### **EARNINGS BY PLACE OF WORK**

Earnings of persons employed in Bon Homme decreased from \$86,724\* in 2000 to \$83,357\* in 2001, a decrease of 3.9 percent. The 2000-2001 state change was 3.4 percent and the national change was 3.1 percent. The average annual growth rate from the 1991 estimate of \$55,970\* to the 2001 estimate was 4.1 percent. The average annual growth rate for the state was 5.6 percent and for the nation was 5.8 percent.
