



BEARFACTS 1991 – 2001

York-Hanover (MSA) [49620]

York-Hanover is one of 363 Metropolitan Statistical Areas (MSAs) in the nation. Its 2001 population of 385,297 ranked 119th in the nation.

PER CAPITA PERSONAL INCOME

In 2001 York-Hanover had a per capita personal income (PCPI) of \$28,230. This PCPI ranked 128th in the United States and was 92 percent of the national average, \$30,582. The 2001 PCPI reflected a decrease of 1.9 percent from 2000. The 2000-2001 national change was 2.5 percent. In 1991 the PCPI of York-Hanover was \$20,388 and ranked 64th in the United States. The 1991-2001 average annual growth rate of PCPI was 3.3 percent. The average annual growth rate for the nation was 4.4 percent.

TOTAL PERSONAL INCOME

In 2001 York-Hanover had a total personal income (TPI) of \$10,876,804*. This TPI ranked 120th in the United States. In 1991 the TPI of York-Hanover was \$7,058,450* and ranked 105th in the United States. The 2001 TPI reflected a decrease of 1.3 percent from 2000. The 2000-2001 national change was 3.5 percent. The 1991-2001 average annual growth rate of TPI was 4.4 percent. The average annual growth rate for the nation was 5.6 percent.

COMPONENTS OF TOTAL PERSONAL INCOME

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of York-Hanover. In 2001 net earnings accounted for 69.5 percent of TPI (compared with 70.0 in 1991); dividends, interest, and rent were 17.0 percent (compared with 18.5 in 1991); and personal current transfer receipts were 13.5 percent (compared with 11.5 in 1991). From 2000 to 2001 net earnings decreased 2.9 percent; dividends, interest, and rent decreased 3.1 percent; and personal current transfer receipts increased 10.8 percent. From 1991 to 2001 net earnings increased on average 4.3 percent each year; dividends, interest, and rent increased on average 3.5 percent; and personal current transfer receipts increased on average 6.1 percent.

EARNINGS BY PLACE OF WORK

Earnings of persons employed in York-Hanover decreased from \$7,540,099* in 2000 to \$7,303,110* in 2001, a decrease of 3.1 percent. The 2000-2001 national change was 3.1 percent. The average annual growth rate from the 1991 estimate of \$5,011,298* to the 2001 estimate was 3.8 percent. The average annual growth rate for the nation was 5.8 percent.
