



BEARFACTS 1991 – 2001 Campbell , Wyoming [56005]

Campbell is one of 23 counties in Wyoming. It is part of the Gillette, WY Micropolitan SA. Its 2001 population of 34,519 ranked 5th in the state.

PER CAPITA PERSONAL INCOME

In 2001 Campbell had a per capita personal income (PCPI) of \$30,512. This PCPI ranked 7th in the state and was 100 percent of the state average, \$30,374, and 100 percent of the national average, \$30,582. The 2001 PCPI reflected an increase of 11.4 percent from 2000. The 2000-2001 state change was 6.7 percent and the national change was 2.5 percent. In 1991 the PCPI of Campbell was \$19,160 and ranked 6th in the state. The 1991-2001 average annual growth rate of PCPI was 4.8 percent. The average annual growth rate for the state was 5.0 percent and for the nation was 4.4 percent.

TOTAL PERSONAL INCOME

In 2001 Campbell had a total personal income (TPI) of \$1,053,236*. This TPI ranked 5th in the state and accounted for 7.0 percent of the state total. In 1991 the TPI of Campbell was \$571,474* and ranked 4th in the state. The 2001 TPI reflected an increase of 13.3 percent from 2000. The 2000-2001 state change was 6.5 percent and the national change was 3.5 percent. The 1991-2001 average annual growth rate of TPI was 6.3 percent. The average annual growth rate for the state was 5.7 percent and for the nation was 5.6 percent.

COMPONENTS OF TOTAL PERSONAL INCOME

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of Campbell. In 2001 net earnings accounted for 77.8 percent of TPI (compared with 77.4 in 1991); dividends, interest, and rent were 14.6 percent (compared with 15.7 in 1991); and personal current transfer receipts were 7.6 percent (compared with 6.8 in 1991). From 2000 to 2001 net earnings increased 16.0 percent; dividends, interest, and rent increased 2.1 percent; and personal current transfer receipts increased 9.6 percent. From 1991 to 2001 net earnings increased on average 6.4 percent each year; dividends, interest, and rent increased on average 5.5 percent; and personal current transfer receipts increased on average 7.5 percent.

EARNINGS BY PLACE OF WORK

Earnings of persons employed in Campbell increased from \$888,993* in 2000 to \$1,048,830* in 2001, an increase of 18.0 percent. The 2000-2001 state change was 8.5 percent and the national change was 3.1 percent. The average annual growth rate from the 1991 estimate of \$539,236* to the 2001 estimate was 6.9 percent. The average annual growth rate for the state was 5.3 percent and for the nation was 5.8 percent.
