



BEARFACTS 1992 – 2002 Greenwood , Kansas [20073]

Greenwood is one of 105 counties in Kansas. It is not part of a Metropolitan Area. Its 2002 population of 7,580 ranked 53rd in the state.

PER CAPITA PERSONAL INCOME

In 2002 Greenwood had a per capita personal income (PCPI) of \$21,746. This PCPI ranked 78th in the state and was 75 percent of the state average, \$28,979, and 71 percent of the national average, \$30,838. The 2002 PCPI reflected a decrease of 0.6 percent from 2001. The 2001-2002 state change was 0.9 percent and the national change was 0.8 percent. In 1992 the PCPI of Greenwood was \$14,791 and ranked 103rd in the state. The 1992-2002 average annual growth rate of PCPI was 3.9 percent. The average annual growth rate for the state was 3.9 percent and for the nation was 4.0 percent.

TOTAL PERSONAL INCOME

In 2002 Greenwood had a total personal income (TPI) of \$164,836*. This TPI ranked 54th in the state and accounted for 0.2 percent of the state total. In 1992 the TPI of Greenwood was \$116,185* and ranked 60th in the state. The 2002 TPI reflected a decrease of 1.7 percent from 2001. The 2001-2002 state change was 1.3 percent and the national change was 1.8 percent. The 1992-2002 average annual growth rate of TPI was 3.6 percent. The average annual growth rate for the state was 4.7 percent and for the nation was 5.2 percent.

COMPONENTS OF TOTAL PERSONAL INCOME

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of Greenwood. In 2002 net earnings accounted for 52.2 percent of TPI (compared with 48.6 in 1992); dividends, interest, and rent were 19.7 percent (compared with 24.4 in 1992); and personal current transfer receipts were 28.0 percent (compared with 27.1 in 1992). From 2001 to 2002 net earnings decreased 1.3 percent; dividends, interest, and rent decreased 10.1 percent; and personal current transfer receipts increased 4.3 percent. From 1992 to 2002 net earnings increased on average 4.3 percent each year; dividends, interest, and rent increased on average 1.4 percent; and personal current transfer receipts increased on average 3.9 percent.

EARNINGS BY PLACE OF WORK

Earnings of persons employed in Greenwood decreased from \$69,068* in 2001 to \$68,505* in 2002, a decrease of 0.8 percent. The 2001-2002 state change was 1.6 percent and the national change was 2.1 percent. The average annual growth rate from the 1992 estimate of \$49,412* to the 2002 estimate was 3.3 percent. The average annual growth rate for the state was 4.9 percent and for the nation was 5.4 percent.
