



BEARFACTS 1992 – 2002

Mount Vernon-Anacortes (MSA) [34580]

Mount Vernon-Anacortes is one of 363 Metropolitan Statistical Areas (MSAs) in the nation. Its 2002 population of 106,126 ranked 325th in the nation.

PER CAPITA PERSONAL INCOME

In 2002 Mount Vernon-Anacortes had a per capita personal income (PCPI) of \$29,547. This PCPI ranked 111th in the United States and was 96 percent of the national average, \$30,838. The 2002 PCPI reflected an increase of 0.3 percent from 2001. The 2001-2002 national change was 0.8 percent. In 1992 the PCPI of Mount Vernon-Anacortes was \$19,253 and ranked 146th in the United States. The 1992-2002 average annual growth rate of PCPI was 4.4 percent. The average annual growth rate for the nation was 4.0 percent.

TOTAL PERSONAL INCOME

In 2002 Mount Vernon-Anacortes had a total personal income (TPI) of \$3,135,695*. This TPI ranked 284th in the United States. In 1992 the TPI of Mount Vernon-Anacortes was \$1,664,327* and ranked 314th in the United States. The 2002 TPI reflected an increase of 1.6 percent from 2001. The 2001-2002 national change was 1.8 percent. The 1992-2002 average annual growth rate of TPI was 6.5 percent. The average annual growth rate for the nation was 5.2 percent.

COMPONENTS OF TOTAL PERSONAL INCOME

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of Mount Vernon-Anacortes. In 2002 net earnings accounted for 62.5 percent of TPI (compared with 60.5 in 1992); dividends, interest, and rent were 20.1 percent (compared with 22.7 in 1992); and personal current transfer receipts were 17.4 percent (compared with 16.7 in 1992). From 2001 to 2002 net earnings increased 2.6 percent; dividends, interest, and rent decreased 5.1 percent; and personal current transfer receipts increased 6.4 percent. From 1992 to 2002 net earnings increased on average 6.9 percent each year; dividends, interest, and rent increased on average 5.3 percent; and personal current transfer receipts increased on average 7.0 percent.

EARNINGS BY PLACE OF WORK

Earnings of persons employed in Mount Vernon-Anacortes increased from \$2,052,425* in 2001 to \$2,116,241* in 2002, an increase of 3.1 percent. The 2001-2002 national change was 2.1 percent. The average annual growth rate from the 1992 estimate of \$1,105,153* to the 2002 estimate was 6.7 percent. The average annual growth rate for the nation was 5.4 percent.
