



BEARFACTS 1992 – 2002

San Miguel , New Mexico [35047]

San Miguel is one of 33 counties in New Mexico. It is part of the Las Vegas, NM Micropolitan SA. Its 2002 population of 29,484 ranked 16th in the state.

PER CAPITA PERSONAL INCOME

In 2002 San Miguel had a per capita personal income (PCPI) of \$19,045. This PCPI ranked 21st in the state and was 78 percent of the state average, \$24,330, and 62 percent of the national average, \$30,838. The 2002 PCPI reflected an increase of 5.5 percent from 2001. The 2001-2002 state change was 0.8 percent and the national change was 0.8 percent. In 1992 the PCPI of San Miguel was \$11,611 and ranked 28th in the state. The 1992-2002 average annual growth rate of PCPI was 5.1 percent. The average annual growth rate for the state was 4.1 percent and for the nation was 4.0 percent.

TOTAL PERSONAL INCOME

In 2002 San Miguel had a total personal income (TPI) of \$561,535*. This TPI ranked 17th in the state and accounted for 1.2 percent of the state total. In 1992 the TPI of San Miguel was \$313,157* and ranked 17th in the state. The 2002 TPI reflected an increase of 4.7 percent from 2001. The 2001-2002 state change was 1.9 percent and the national change was 1.8 percent. The 1992-2002 average annual growth rate of TPI was 6.0 percent. The average annual growth rate for the state was 5.7 percent and for the nation was 5.2 percent.

COMPONENTS OF TOTAL PERSONAL INCOME

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of San Miguel. In 2002 net earnings accounted for 56.9 percent of TPI (compared with 58.6 in 1992); dividends, interest, and rent were 12.7 percent (compared with 13.9 in 1992); and personal current transfer receipts were 30.4 percent (compared with 27.5 in 1992). From 2001 to 2002 net earnings increased 6.1 percent; dividends, interest, and rent decreased 11.3 percent; and personal current transfer receipts increased 10.5 percent. From 1992 to 2002 net earnings increased on average 5.7 percent each year; dividends, interest, and rent increased on average 5.0 percent; and personal current transfer receipts increased on average 7.1 percent.

EARNINGS BY PLACE OF WORK

Earnings of persons employed in San Miguel increased from \$269,319* in 2001 to \$287,490* in 2002, an increase of 6.7 percent. The 2001-2002 state change was 3.7 percent and the national change was 2.1 percent. The average annual growth rate from the 1992 estimate of \$181,090* to the 2002 estimate was 4.7 percent. The average annual growth rate for the state was 5.6 percent and for the nation was 5.4 percent.
