



BEARFACTS 1993 – 2003

Cape Coral-Fort Myers (MSA) [15980]

Cape Coral-Fort Myers is one of 363 Metropolitan Statistical Areas (MSAs) in the nation. Its 2003 population of 490,023 ranked 97th in the nation.

PER CAPITA PERSONAL INCOME

In 2003 Cape Coral-Fort Myers had a per capita personal income (PCPI) of \$32,129. This PCPI ranked 75th in the United States and was 102 percent of the national average, \$31,530. The 2003 PCPI reflected an increase of 2.9 percent from 2002. The 2002-2003 national change was 2.2 percent. In 1993 the PCPI of Cape Coral-Fort Myers was \$21,128 and ranked 91st in the United States. The 1993-2003 average annual growth rate of PCPI was 4.3 percent. The average annual growth rate for the nation was 4.0 percent.

TOTAL PERSONAL INCOME

In 2003 Cape Coral-Fort Myers had a total personal income (TPI) of \$15,743,763*. This TPI ranked 87th in the United States. In 1993 the TPI of Cape Coral-Fort Myers was \$7,794,947* and ranked 108th in the United States. The 2003 TPI reflected an increase of 6.4 percent from 2002. The 2002-2003 national change was 3.1 percent. The 1993-2003 average annual growth rate of TPI was 7.3 percent. The average annual growth rate for the nation was 5.1 percent.

COMPONENTS OF TOTAL PERSONAL INCOME

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of Cape Coral-Fort Myers. In 2003 net earnings accounted for 52.1 percent of TPI (compared with 47.3 in 1993); dividends, interest, and rent were 31.0 percent (compared with 34.3 in 1993); and personal current transfer receipts were 16.9 percent (compared with 18.3 in 1993). From 2002 to 2003 net earnings increased 11.5 percent; dividends, interest, and rent decreased 1.5 percent; and personal current transfer receipts increased 6.7 percent. From 1993 to 2003 net earnings increased on average 8.3 percent each year; dividends, interest, and rent increased on average 6.2 percent; and personal current transfer receipts increased on average 6.4 percent.

EARNINGS BY PLACE OF WORK

Earnings of persons employed in Cape Coral-Fort Myers increased from \$8,041,970* in 2002 to \$8,967,897* in 2003, an increase of 11.5 percent. The 2002-2003 national change was 3.8 percent. The average annual growth rate from the 1993 estimate of \$4,111,855* to the 2003 estimate was 8.1 percent. The average annual growth rate for the nation was 5.3 percent.
