



BEARFACTS 1993 – 2003

Jefferson Davis , Louisiana [22053]

Jefferson Davis is one of 64 counties in Louisiana. It is part of the Jennings, LA Micropolitan SA. Its 2003 population of 30,874 ranked 34th in the state.

PER CAPITA PERSONAL INCOME

In 2003 Jefferson Davis had a per capita personal income (PCPI) of \$20,290. This PCPI ranked 42nd in the state and was 78 percent of the state average, \$25,862, and 64 percent of the national average, \$31,530. The 2003 PCPI reflected an increase of 7.6 percent from 2002. The 2002-2003 state change was 2.4 percent and the national change was 2.2 percent. In 1993 the PCPI of Jefferson Davis was \$13,085 and ranked 51st in the state. The 1993-2003 average annual growth rate of PCPI was 4.5 percent. The average annual growth rate for the state was 4.0 percent and for the nation was 4.0 percent.

TOTAL PERSONAL INCOME

In 2003 Jefferson Davis had a total personal income (TPI) of \$626,423*. This TPI ranked 36th in the state and accounted for 0.5 percent of the state total. In 1993 the TPI of Jefferson Davis was \$405,242* and ranked 36th in the state. The 2003 TPI reflected an increase of 7.4 percent from 2002. The 2002-2003 state change was 2.6 percent and the national change was 3.1 percent. The 1993-2003 average annual growth rate of TPI was 4.5 percent. The average annual growth rate for the state was 4.4 percent and for the nation was 5.1 percent.

COMPONENTS OF TOTAL PERSONAL INCOME

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of Jefferson Davis. In 2003 net earnings accounted for 60.9 percent of TPI (compared with 57.8 in 1993); dividends, interest, and rent were 14.3 percent (compared with 16.9 in 1993); and personal current transfer receipts were 24.8 percent (compared with 25.3 in 1993). From 2002 to 2003 net earnings increased 12.7 percent; dividends, interest, and rent decreased 3.2 percent; and personal current transfer receipts increased 2.0 percent. From 1993 to 2003 net earnings increased on average 5.0 percent each year; dividends, interest, and rent increased on average 2.8 percent; and personal current transfer receipts increased on average 4.2 percent.

EARNINGS BY PLACE OF WORK

Earnings of persons employed in Jefferson Davis increased from \$242,954* in 2002 to \$293,500* in 2003, an increase of 20.8 percent. The 2002-2003 state change was 4.4 percent and the national change was 3.8 percent. The average annual growth rate from the 1993 estimate of \$192,607* to the 2003 estimate was 4.3 percent. The average annual growth rate for the state was 4.7 percent and for the nation was 5.3 percent.
