



BEARFACTS 1993 – 2003

Queen Anne's , Maryland [24035]

Queen Anne's is one of 24 counties in Maryland. It is part of the [Baltimore-Towson, MD \(MSA\)](#). Its 2003 population of 43,774 ranked 18th in the state.

PER CAPITA PERSONAL INCOME

In 2003 Queen Anne's had a per capita personal income (PCPI) of \$36,466. This PCPI ranked 6th in the state and was 97 percent of the state average, \$37,441, and 116 percent of the national average, \$31,530. The 2003 PCPI reflected an increase of 3.6 percent from 2002. The 2002-2003 state change was 2.4 percent and the national change was 2.2 percent. In 1993 the PCPI of Queen Anne's was \$23,048 and ranked 8th in the state. The 1993-2003 average annual growth rate of PCPI was 4.7 percent. The average annual growth rate for the state was 4.2 percent and for the nation was 4.0 percent.

TOTAL PERSONAL INCOME

In 2003 Queen Anne's had a total personal income (TPI) of \$1,596,249*. This TPI ranked 17th in the state and accounted for 0.8 percent of the state total. In 1993 the TPI of Queen Anne's was \$815,798* and ranked 19th in the state. The 2003 TPI reflected an increase of 6.4 percent from 2002. The 2002-2003 state change was 3.5 percent and the national change was 3.1 percent. The 1993-2003 average annual growth rate of TPI was 6.9 percent. The average annual growth rate for the state was 5.3 percent and for the nation was 5.1 percent.

COMPONENTS OF TOTAL PERSONAL INCOME

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of Queen Anne's. In 2003 net earnings accounted for 73.1 percent of TPI (compared with 69.2 in 1993); dividends, interest, and rent were 16.9 percent (compared with 21.1 in 1993); and personal current transfer receipts were 9.9 percent (compared with 9.7 in 1993). From 2002 to 2003 net earnings increased 7.5 percent; dividends, interest, and rent increased 1.0 percent; and personal current transfer receipts increased 8.9 percent. From 1993 to 2003 net earnings increased on average 7.5 percent each year; dividends, interest, and rent increased on average 4.6 percent; and personal current transfer receipts increased on average 7.2 percent.

EARNINGS BY PLACE OF WORK

Earnings of persons employed in Queen Anne's increased from \$496,365* in 2002 to \$566,638* in 2003, an increase of 14.2 percent. The 2002-2003 state change was 4.3 percent and the national change was 3.8 percent. The average annual growth rate from the 1993 estimate of \$243,776* to the 2003 estimate was 8.8 percent. The average annual growth rate for the state was 5.7 percent and for the nation was 5.3 percent.
