



BEARFACTS 1993 – 2003

Nuckolls , Nebraska [31129]

Nuckolls is one of 93 counties in Nebraska. It is not part of a Metropolitan Area. Its 2003 population of 4,805 ranked 58th in the state.

PER CAPITA PERSONAL INCOME

In 2003 Nuckolls had a per capita personal income (PCPI) of \$25,872. This PCPI ranked 52nd in the state and was 84 percent of the state average, \$30,811, and 82 percent of the national average, \$31,530. The 2003 PCPI reflected an increase of 19.1 percent from 2002. The 2002-2003 state change was 5.4 percent and the national change was 2.2 percent. In 1993 the PCPI of Nuckolls was \$17,150 and ranked 56th in the state. The 1993-2003 average annual growth rate of PCPI was 4.2 percent. The average annual growth rate for the state was 4.5 percent and for the nation was 4.0 percent.

TOTAL PERSONAL INCOME

In 2003 Nuckolls had a total personal income (TPI) of \$124,316*. This TPI ranked 59th in the state and accounted for 0.2 percent of the state total. In 1993 the TPI of Nuckolls was \$95,952* and ranked 57th in the state. The 2003 TPI reflected an increase of 19.2 percent from 2002. The 2002-2003 state change was 6.0 percent and the national change was 3.1 percent. The 1993-2003 average annual growth rate of TPI was 2.6 percent. The average annual growth rate for the state was 5.2 percent and for the nation was 5.1 percent.

COMPONENTS OF TOTAL PERSONAL INCOME

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of Nuckolls. In 2003 net earnings accounted for 55.2 percent of TPI (compared with 53.6 in 1993); dividends, interest, and rent were 21.6 percent (compared with 25.9 in 1993); and personal current transfer receipts were 23.2 percent (compared with 20.5 in 1993). From 2002 to 2003 net earnings increased 48.5 percent; dividends, interest, and rent decreased 7.0 percent; and personal current transfer receipts decreased 1.5 percent. From 1993 to 2003 net earnings increased on average 2.9 percent each year; dividends, interest, and rent increased on average 0.8 percent; and personal current transfer receipts increased on average 3.9 percent.

EARNINGS BY PLACE OF WORK

Earnings of persons employed in Nuckolls increased from \$42,502* in 2002 to \$64,927* in 2003, an increase of 52.8 percent. The 2002-2003 state change was 7.5 percent and the national change was 3.8 percent. The average annual growth rate from the 1993 estimate of \$52,967* to the 2003 estimate was 2.1 percent. The average annual growth rate for the state was 5.2 percent and for the nation was 5.3 percent.
