



BEARFACTS 1993 – 2003

Robertson , Texas [48395]

Robertson is one of 254 counties in Texas. It is part of the [College Station-Bryan, TX \(MSA\)](#). Its 2003 population of 15,730 ranked 135th in the state.

PER CAPITA PERSONAL INCOME

In 2003 Robertson had a per capita personal income (PCPI) of \$24,207. This PCPI ranked 105th in the state and was 82 percent of the state average, \$29,436, and 77 percent of the national average, \$31,530. The 2003 PCPI reflected an increase of 10.4 percent from 2002. The 2002-2003 state change was 2.0 percent and the national change was 2.2 percent. In 1993 the PCPI of Robertson was \$13,552 and ranked 219th in the state. The 1993-2003 average annual growth rate of PCPI was 6.0 percent. The average annual growth rate for the state was 4.2 percent and for the nation was 4.0 percent.

TOTAL PERSONAL INCOME

In 2003 Robertson had a total personal income (TPI) of \$380,777*. This TPI ranked 129th in the state and accounted for 0.1 percent of the state total. In 1993 the TPI of Robertson was \$209,413* and ranked 144th in the state. The 2003 TPI reflected an increase of 9.9 percent from 2002. The 2002-2003 state change was 3.6 percent and the national change was 3.1 percent. The 1993-2003 average annual growth rate of TPI was 6.2 percent. The average annual growth rate for the state was 6.2 percent and for the nation was 5.1 percent.

COMPONENTS OF TOTAL PERSONAL INCOME

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of Robertson. In 2003 net earnings accounted for 62.2 percent of TPI (compared with 55.1 in 1993); dividends, interest, and rent were 14.2 percent (compared with 18.4 in 1993); and personal current transfer receipts were 23.6 percent (compared with 26.5 in 1993). From 2002 to 2003 net earnings increased 13.4 percent; dividends, interest, and rent increased 1.2 percent; and personal current transfer receipts increased 6.7 percent. From 1993 to 2003 net earnings increased on average 7.5 percent each year; dividends, interest, and rent increased on average 3.4 percent; and personal current transfer receipts increased on average 4.9 percent.

EARNINGS BY PLACE OF WORK

Earnings of persons employed in Robertson increased from \$145,494* in 2002 to \$172,121* in 2003, an increase of 18.3 percent. The 2002-2003 state change was 3.5 percent and the national change was 3.8 percent. The average annual growth rate from the 1993 estimate of \$108,497* to the 2003 estimate was 4.7 percent. The average annual growth rate for the state was 6.5 percent and for the nation was 5.3 percent.
